This announcement is sent to remind you of the **Panther Employee Scholarship Program**. Prairie View A&M University believes that receiving a quality education opens the door of endless possibilities for not only our current students, but also our faculty and staff. This initiative will financially assist our eligible faculty, staff or their spouses or dependents who aspire to complete their degree and/or certification, right here at our great Institution. The program pays up to 6 hours per semester for each fall, spring and summer term for a total of up to 18 hours per academic year.

For current employees utilizing the program, this is a reminder that you must submit an application for each semester you wish to receive benefits.
