## 2019-2020 GENERAL SCHOLARSHIP AGREEMENT

I, \_\_\_\_\_, hereby acknowledge and agree to the following guidelines:

- I. I understand that Prairie View A&M University reserves the right to modify my award (financial aid/scholarship) at any time due to changes in my eligibility, enrollment status, housing status, availability of funding; or receipt of any funds not included in my original award package
- II. I must utilize the scholarship to pay towards the cost of attending Prairie View A&M University
- III. I understand that this scholarship has been awarded based upon my financial information and may be adjusted at any time due to changes in my financial information
- IV. I must satisfy all outstanding financial aid requirements before the award may be credited

- V. I must make satisfactory academic progress in all coursework in order to receive the scholarship
- VI. I understand that I must maintain full-time enrollment (12 credit hours or more) as an undergraduate or enrollment in 6 credit hours or more as a graduate student to maintain eligibility of my scholarship
- VII. I understand that this scholarship may not be applied towards the costs of summer courses or related expenses
- VIII. I understand that if I withdraw from the university at any point in time during the term in which the scholarship funding has been applied, the scholarship funding will be removed from my account and I will be responsible for the balance created if any
- IX. I understand the scholarship may be terminated in the event that I am suspended from the institution for violating the university's disciplinary code, fail to meet the continued eligibility requirements, or do not enroll for the period of the award.

**X. FERPA Notice**

The Family Education Rights and Privacy Act of 1974 (FERPA), initially called the Buckley Amendment, allows students at an institution of higher education to control outside access to their education records, including requests for information from their parents, guardians, or others as designated any the student. Without a student's written consent the college or university may not disclose information from the student's education records to outside third parties. However, students can allow the release of information. To do so, the following agreement must be completed.
