## 2018 - 2019 Dependent Verification Worksheet – V4

Your application was selected for review in a process called Verification by the U.S. Department of Education. The financial aid program rule ((34 CFR, Part 668)) states that before awarding federal student aid, PVAMU may ask you to confirm the information reported on your Federal Application for Federal Student Aid (FAFSA). Attach all other documents listed under <u>"Unsatisfied Requirements</u> in your <u>Panther Tracks</u> and submit them to the PVAMU Office of Student Financial Aid & Scholarships via Panther Pass. If there are differences between your application information and your financial documents PVAMU will need to make the necessary corrections. <u>Responsibility of PV Students</u>: If the requested documents are not complete, as well as received in a timely manner, any aid the student has received may be cancelled and the student risks being dropped from registered courses.

Academic transcript of a successfully completed two-year program acceptable for full credit toward a bachelor's degree
For a homeschooled student from a state where state law requires the student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a copy of that credential.
For a homeschooled student from a state where state law does not require the student to obtain a secondary school completion for homeschool (other than a high school diploma or its recognized equivalent), a transcript or the equivalent, signed by the student's parent or guardian, that lists the secondary school courses the student completed and includes a statement that the student successfully completed a secondary school education in a homeschool setting.

#### C. Documentation of Identity/Statement of Educational Purpose

In order to complete the Verification process, you will need to appear in person at your postsecondary institution, *attach a copy of your government issued ID* (such as a driver's license, military ID, passport, etc.) and submit this verification worksheet to an institutionally authorized financial aid administrator. Your financial aid administrator will need to validate the statement below at the time of submission by maintaining a copy of your photo ID and by providing a signature and date. *If you cannot appear in person to submit this worksheet, you will need to provide a copy of your government issued ID and this worksheet notarized by a public notary*
