
# Community Garden




On May 31, 2025, the Northwest Houston Center connected with PVAMU Wellness and Houston to host our first annual Community Garden Day at PVAMU Northwest Campus. After months of hard work and planning, the community garden event was a success. There was an enormous turnout of faculty, staff, students, and community members. Mrs. Tonnie (NWHC), Mrs. Gale (John B Coleman Library), and Mr. Quincy (Wellness in Houston) provided a very hands-on experience that connected to the broader lessons about patience, perseverance, responsibility, and the interconnectedness of nature. I attended the event and I was taught the importance of observation and understanding of sustainability and environmental stewardship. Gardening has its way of nurturing the mind and body as one takes in the sights of nature. The garden was seen not as a project to be controlled, but as a living ecosystem requiring nurturing and care. # PVAMU Northwest Houston Center Teams with PVAMU Extension, Childs Legacy Law Firm, P.C. to Help Families Protect and Hold On To Their Property

Ms. Angela Moore, Program Coordinator for PVAMU Extension within the College of Agriculture, Food, and Natural Resources, along with representatives of Childs Legacy Law Firm, P.C., presented at the "Show Me the Money" forum held at the PVAMU Northwest Houston Center on April 5, 2025. This forum was the first in a monthly series on the topic of Heirs' Property and Estate Planning that is offered free of charge as a service to members of the community. "We are delighted to be a part of this collaboration as we believe raising awareness about tools to help protect assets will help families keep their land," said Dr. Kamala Williams, Director, PVAMU Northwest Houston Center.

Ms. Moore's presentation stressed the importance of protecting and preserving heirs' property which left the audience feeling a sense of urgency to communicate with family members and make efforts to protect their own family property from potential loss. Moore noted while heirs' property is most prevalent in the Southeast region of the United States, it exists throughout the nation and can impact any family. The forced sale of heirs' property is one tactic that can lead to land loss and is a trend that appears to be on the rise as more and more investors are using this as a business model. Ms. Moore concluded her presentation by urging attendees to take steps to protect their assets by creating an estate plan. This call to action provided a smooth transition to the next presentations on Estate Planning by Ms. Eraka Childs, Esq. and Mr. Chris Watson, of Childs Legacy Law Firm, P.C.


