We want to help you remain as a student at Prairie View A&M University.

Dear Summer 2018 Student:

Thank you for selecting Prairie View A&M University as your college of choice. To be enrolled as a student at Prairie View A&M University you must have paid 100% of your Summer 2018 * tuition and mandatory fees* or have completed all financial aid document requirements as verified by Student Financial Aid. Our records indicate that you have not paid 100% of tuition and mandatory fees* or have pending financial aid for Summer Classes, therefore, your registration has been cancelled and you are not an officially enrolled student. If our records are incorrect, please contact the Accounts Receivable Office at (936) 261-1890 within 3 days of receipt of this letter but no later than Friday, **June 20, 2018**.

You may be reinstated provided that:

- **You make payment*** of 100% of tuition and mandatory fees* for Summer 2018*, plus a late installment fee of \$25.00 or have Student Financial Aid certify that you have pending aid that will pay 100% of tuition and mandatory fees* for Summer*.
- **REINSTATEMENT WILL NOT BE CONSIDERED AFTER June 20, 2018.**

***Summer tuition and mandatory fees are Full-Term -1 (10 week) and Part of Term-5A (first 5 week) registration fees.**

Payments must be in the form of Financial Aid such as Grants, Scholarships, Loans, etc. or in the form of personal funds such as Cash, Credit Card or Debit Card (No personal checks will be accepted for reinstatement**). If you are expecting financial aid and it has not been posted to your account, please contact your financial aid counselor at fadmail@pvamu.edu or visit the financial aid web-site at www.pvamu.edu/faid, check aid status at <http://panthertracks.pvamu.edu/> or check your PVAMU e-mail account for important information. The Financial Aid Office is located in the Memorial Student Center on the 3rd floor. You may reach the office by phone at (936) 261-1000 Option #1.*

Making Payments:

Credit card payments are accepted at the Cashier's Window (Suite 140 WR Banks), student web portal (Panthertracks), and by telephone at 936-261-1895. Students **must** notify the Cashier's Office of the web payment by calling (936) 261-1895, or email stuar@pvamu.edu so that a reinstatement form may be processed. **Personal checks or e-checks will not be accepted when requesting reinstatement.** Please send cashier check or money order. Reinstatement...*If you wish to be reinstated, you must complete the attached Reinstatement Process Form and submit it to the Office of Financial Aid (3rd Floor MSC) or to the Cashiers (1st Floor WR BANKS). Payment will be required before you are reinstated or you must have approval from Financial Aid that you have aid which covers your required payment.*

Wish to Withdraw...*You must properly withdraw from the university by completing the Withdrawal process (see website below) and submitting your request to the Office of the Registrar (3rd Floor MSC). Failure to properly withdraw may cause you to have an additional balance due and failing grades.*
