Course Procedures or Additional Instructor Policies

Taskstream

Taskstream is a tool that Prairie View A&M University uses for assessment purposes. One of your assignments may be required to be submitted as an "artifact," an item of coursework that serves as evidence that course objectives are met. If applicable, more information will be provided during the semester, but for general information, you can visit Taskstream via the link in eCourses.

Communication and Response Time

Students are encouraged to communicate any questions or concerns via the REMIND app, Canvas email, or calling the office phone. The instructor will respond to all emails within 24 hours Monday – Thursday. Messages sent after noon on Friday's, over the weekend or during holidays will be responded to the next business day.

Attendance

This course will emphasize the ability to work responsibly and enhance critical thinking skills. As a result, participation in class activities is crucial, and students are expected to participate fully. Because this class uses eCourses (Canvas), most participation and class activities will be tracked through PVAMU's eCourses (Canvas Learning Management System).

Assignments

Assignments are administered and submitted through PVAMU's eCourses (Canvas) and possibly through Cengage MindTap. All assignments will have a cutoff date for submission. Assignments will not be accepted after the cutoff date. Office 365 assignments require the submission of Windows based software files to the Cengage assignment drop boxes. Detailed instructions are provided within the Canvas course. When submitting assignments, the use of PC based software as opposed to Apple based software is required. Free or virtual software is available and detailed within the course.

Quizzes

Quizzes are timed with enough time for a typical student to be able to read, pause and answer the question. There are no makeup quizzes. You may contact to your Instructor to request to take it early if you know you will be missing class for a justifiable reason (i.e. court appointment, funeral, work obligations, etc.).

Tests (major exams)

All tests (major exams) are <u>closed book</u> unless specifically stated otherwise by the instructor. All tests (major exams) are to be <u>individually</u> completed unless specifically stated otherwise by the instructor. There are no makeup exams. You may contact to your instructor about taking something early if you know you will be missing class for a justifiable reason (i.e. court appointment, funeral, work obligations, etc.).

Cell phone are not allowed during tests. If you test stops then re-enter the test as soon as possible to finish the test. Make-up tests or late submission tests are not allowed. If you have an unexcused absence and miss a test then your Final Exam grade can replace your missing or lowest test grade. If a student has questionably integrity concerns then this accommodation will be lost and not extended.

Final Exam

The comprehensive final exam includes questions from all assigned chapters of the *Programming and Problem Solving with C++* textbook or eBook and is administered via the Canvas course platform. The final exam is <u>closed</u> <u>book</u> and is to be completed <u>individually</u>. There is not a makeup final. Final exams are to be given during the final exam time specified by Prairie View A&M University (<u>https://www.pvamu.edu/registrar/general-registration-</u> <u>information/final-exam-schedule/</u>). If you have an extenuating circumstance impacting the final exam time, please contact your instructor in writing.

Extenuating circumstances

Academic Misconduct

Academic dishonesty is defined as any form of cheating or dishonesty that has the effect or intent of interfering with any academic exercise or fair evaluation of a student's performance. You are expected to practice academic honesty in every aspect of this course and all other courses. Student Code of Conduct, the following are examples of prohibited conduct. This list is not designed to be all-inclusive or exhaustive. In addition to academic sanctions, any student found to have committed academic misconduct that is also a violation of criminal law may also be subject to disciplinary review and action by the Office of Student Conduct (as outlined in the Student Code of Conduct).

Forms of Academic Dishonesty:

- <u>Cheating</u>: Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
- 2. <u>Plagiarism</u>: Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;
- 3. <u>Collusion</u>: When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
- 4. <u>Conspiracy</u>: Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and
- 5. <u>Multiple Submission</u>: Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.

Nonacademic Misconduct

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the inability of other students to profit from the instructional program, or (3) campus behavior that interferes with the rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

Netiquette (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

Video Conferencing Etiquette

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. Before the class session begins, test audio, video, and lighting to alleviate technology issues.

Communication Expectations and Standards

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

Discussion Requirement

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized by the use of the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.

COVID-19 Campus Safety Measures

- **Face Coverings** Face coverings (cloth face covering, surgical mask, etc.) are recommended in classrooms, teaching laboratories, common spaces such as lobbies and hallways, public study spaces, libraries, academic resource, and support offices, and outdoor spaces where 6 feet of physical distancing is challenging to maintain reliably.
- **Physical Distancing** Physical distancing should be maintained between students, instructors, and others in course and course-related activities where possible.
- **Personal Illness and Quarantine** Students required to quarantine are to participate in courses and courserelated activities remotely and must not attend face-to-face course activities. Students should notify their instructors of the quarantine requirement. Students under quarantine are expected to participate in courses and complete graded work unless they have symptoms that are too severe to participate in course activities. Students experiencing personal injury or illness that is too severe for the student to attend class qualify for an excused absence.
