Practice Nursing

Catalog Description: Role theory is utilized for analyzing the dimensions of the

role of the APN. Competencies of the APN are examined. Ethical decision-making models are explored to promote role transition and integration. The legal bases of the role

are also presented.

Course Outcomes: Upon completion of the course the student will be able to:

1. Compare and contrast the APN role with other models of advanced nursing practice within the primary health care framework.

- 2. Discuss ethical-legal issues associated with health care delivery in underserved clients in urban and rural settings.
- 3. Evaluate legal and ethical aspects of decision making from both a personal and professional perspective.
- 4. Develop and integrate a personal philosophy regarding the role of the family nurse practitioner in various heath care settings, including ethical and legal implications of the APN role.

- 4. Plagiarism: unacknowledged quotation and/or paraphrase of someone else's words, ideas, or data as one's own in work submitted for credit. Failure to identify information or essays from the Internet and submitting them as one's own work also constitutes plagiarism.

Nonacademic misconduct (See Student Handbook)

Student Academic Appeals Process

Once the post(s) have been typed and corrected in the word processing application, it should be copied and pasted to the discussion board.
