If a student has stopped attending the course (i.e. "stopped out") at any point after the first day of class but did not officially withdraw from the course and has missed assignments and exams, including the final exam, and performed below the grade level of a D, a grade of FN (failed-non attendance) will be assigned for the final course grade to ensure compliance with the federal Title IV financial aid regulations. # Detailed Description of Major Assignments

#### (Consult the Calendar below for all due dates!)

Assignment Title or Grade Requirement	Description
1. Exams (Altogether = 430 points)	You will take three non-cumulative multiple-choice exams. They will be held online and require use of the Lockdown Browser (consult your instructor). The following campus facilities offer access to it: JB Coleman Library (rooms 210 and 210B and the Student Success Center on the third floor), MSC (1st floor main lab), Farrell Hall (1st floor main lab), Delco (room 301), Hobart Taylor (room 1A109), and E.E. O'Banion ("New") Science (room 123). Exam #1 (Chs.1-3) will be worth 110 points, Exam #2 (Chs.4-7) 140 points, and Exam #3 (Chs.8-13&16) 180 points.
2. Chapter Review Quizzes (195 points)	Every chapter will be followed by review quizzes (13 sets, total). You are required to answer all these questions. Unlike the actual exams, you can retake these questions as many times as you like. Each review quiz will be worth 15 points unless noted differently (either 10 or 20 points).
3. Essay Assignments (225 points)	Students are required to complete three essay assignments, which will be worth 75 points, respectively. <u>Please go over my detailed instructions</u> and rubric on these assignments on our Canvas website and <u>check your assignment due dates</u> . Essay #1 will address political history & civic engagement, Essay #2 civil liberties and rights, and Essay #3 political parties and Congress.
4. Writing Assignment (100 points)	Prompt:

In the landmark case, *Shelby County V. Holder (2013)*, the US Supreme Court struck down major provisions of the 1965 Voting Rights Act relating to the procedure of "preclearance." Since the ruling, states like Texas, Georgia and North Carolina, can now make changes to their voting laws, such as photo ID requirements, that do not need to be pre-approved by the federal government. Supporters of this ruling say the pre-clearance rules are no longer needed and besides, states need new laws to protect against voter fraud. Opponents say that these laws are just a new form of voter suppression tactics that hit the poor and racial minorities hardest. Based on this, your paper must meet the following content, format and submission requirements:

#### **CONTENT REQUIREMENTS:**

- 1. Describe the provisions (parts) of the *Voting Rights Act* that discuss the issue of "preclearance".
- 2. Compare and contrast the views of those who think the federal government should have the power of "pre-clearance" and those who do not. Include at least three points of comparison.
- 3. Using evidence from any election in 2014 or later, **argue** whether or not you believe the federal government should have the power of "pre-clearance" relating to election laws. Include at least three reasons and/or examples to make your point.
- 4. List at least two things you could do in order to engage in the political process in pursuit of your position in (3) above.
- 5. Cite at least three (3) reliable, quality references within the body of the paper using the <u>Chicago Manual of Style's</u> parenthetical citation style. One of the citations MUST come from the class textbook (-10 points if this is not done). You must have at least three parenthetical citations in the body of the paper that correctly match the sources properly formatted in the Works Cited Page.

# A paper with no parenthetical source citations in its body will receive a grade of 0.

A paper with no works cited section (a.k.a. list of references, a.k.a. bibliography) at the end of the body will receive a grade of 0.

### FORMAT REQUIREMENTS:

- 1. Typed, 2-3 pages (not counting Works Cited Page), 12-point font, double-spaced.
- 2. Your name, my name, POSC 2305, and the date.
- 3. A title is required, but a separate title page is not necessary.
- 4. An introduction with a thesis/statement of purpose in the first paragraph: "This paper will..."
- 5. A logically organized and sequenced body followed by a clearly stated conclusion.
- 6. Use of the <u>Chicago Manual of Style's</u> parenthetical citation format. Students must be very careful and pay attention to details when they examine and cite internet sources. A paper with no parenthetical source citations and/or no Works Cited Page at the end will receive a grade of 0; no second chances will be allowed.
- 7. Use of footnotes or endnotes is prohibited.
- 8. Using encyclopedias, like Wikipedia, Ballotpedia, history.com, kids.law.com, etc. is prohibited (-10 points).
- 9. Use of word mixers like Spinbot is prohibited and will result in a grade of 0; no second chances will be allowed. Also, see the statements below regarding academic integrity, plagiarism, and generative artificial intelligence, such as ChatGPT.

#### SUBMISSION REQUIREMENTS

- 1. Your paper must be submitted in eCourses. You do NOT need a code; log into eCourses and click on the link that says, "Writing Assignment," then click on the submission tab and follow the prompts to upload your paper.
- 2. A paper placed in my office, in my mailbox or emailed will not be accepted for grading.

	Papers are graded according to the following four criteria: 1) content; 2) organization; 3) quality of writing; and 4) quality of research sources, and reference citation formats. Students are highly recommended to visit the Writing Center before they turn in their papers.
5. Academic Integrity certificate (25 points)	Students are required to complete BOTH the "Academic Integrity Library Online Course" AND the "Academic Integrity Module.". In the first week, please go over all the information provided in the syllabus and the class contract to perform well in this course. If students do not accept the terms and conditions listed in the class contract, they are advised to change to a different class. The class contract is valid through the end of the semester.
7. Extra Credit Assignments (up to 30 points)	There will be several extra credit assignments throughout the semester. Up to 30 points will be added to your final grade.

# Course Procedures or Additional Instructor Policies

Attendance Policy: This course will be asynchronous (i.e., we are not meeting in person nor virtually). I will upload weekly course materials on Canvas every Monday morning starting Week2. You do not have to finish each module by the end of our scheduled time. However, you cannot move on to the next module unless you finish the previous one. So please try to keep up with the schedule, stated in the syllabus.

**Late/Tardy Policy:** 1) Assignments: <u>No extensions will be allowed</u> (with the exception of extraordinary cases in which prior instructor's consent is required before the deadline for the assignment). Students who do not submit their work on time will be penalized <u>10% of the maximum points for each day</u> they do not submit their work. Work that is submitted <u>four days or more after the deadline</u> will receive a grade of **zero** for the assignment. The due dates of assignments are clearly marked in the course schedule and it is **your responsibility** to know when assignments are due. 2) I do **not** accept late <u>extra credit assignments</u>.

**Make-up Policy:** You will only be allowed to make up an exam or assignment <u>if you have a valid excuse</u>. Valid excuses include documented illness, school or business trips, or family crises. Without proper documentation, there will be no makeup assignments. <u>To verify your absence (or make-up excuses)</u>, please follow the University's <u>official instructions below</u>. 3) All course materials will be posted on Canvas, which is available at <u>http://ecourses.pvamu.edu</u>. You are expected to use this website as a resource for the class; in particular, the weekly "to-do list" page of every module should be the starting point. <u>I expect you to check the weekly "to-do list" page (under the Modules tab) every Monday</u> <u>afternoon</u>, since I will post it every Monday morning, except for the first week. In terms of important announcements, I post them under the Announcements tab on Canvas but I also send them via email/message. <u>So, I expect you to check your PVAMU email account at least once a day.</u>

4) It usually takes for me to respond to your emails approximately <u>one-two</u> business days. <u>Please be aware that I do</u> <u>not check emails on weekends; if you send me an email Friday afternoon, you are expected to wait until Monday.</u> Feedback and grades on your assignments will be all available through Canvas. **Political Science Program Policy on Plagiarism:** Plagiarism is a serious academic crime and the Political Science Program has a strict, rigorous enforcement policy for students who commit plagiarism. In general, plagiarism is using another person's words, statistics, and/or ideas as if they were your own. Plagiarism, which is formally defined in the University Rules and Procedures section of this syllabus, can come in many forms, such as directly quoting a source without quotation marks, taking another student's work, directly quoting a source without giving a reference citation and so forth. It is incumbent on students to seek help from the instructor or other University resources to avoid even the appearance of plagiarism in their work. If in doubt, CITE THE SOURCE! Any student caught committing ANY type of plagiarism in a Political Science course will receive one OR MORE of the following punishments, depending on the severity of the offense and in accordance with the Student Code of Conduct:

1. Grade Penalty (an F for the assignment or for the course) in addition to cancellation of any extra credit points

2. Letter of Reprimand

- 3. Probation
- 4. Suspension
- 5. Dismissal from Academic Program
- 6. Expulsion from the university.

Students must consult the University's Code of Conduct for other forms of academic dishonesty and punishments.

#### *Netiquette* (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. <u>Students are to be</u> respectful and courteous to others on discussions boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. <u>Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you."</u> Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post and the message might be taken seriously or sound offensive.

#### **Video Conferencing Etiquette**

When using Zoom, WebEx or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. <u>Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking</u> and avoid eating/drinking during session. Before class session begins, test audio, video and lighting to alleviate technology issues.

**Grade Groveling Policy:** Students concerned about their grades should endeavor to attend all class sessions and complete all work to the best of their ability. Students **earn** high grades, based on demonstrating mastery of the subject matter and not based on what they want or need for their overall GPA. Therefore, no grade groveling will be entertained and no "do-overs" allowed.

## University Rules and Procedures

#### Academic Misconduct

Academic dishonesty is defined as any form of cheating or dishonesty that has the effect or intent of interfering with any academic exercise or fair evaluation of a student's performance. The college faculty can provide additional information, particularly related to a specific course, laboratory, or assignment.

You are expected to practice academic honesty in every aspect of this course and all other courses. Make sure you are familiar with the *University Administrative Guidelines on Academic Integrity*, which can be found on the <u>Academic Integrity webpage</u>. Students who engage in academic misconduct are subject to university disciplinary procedures. As listed in the *University Administrative Guidelines on Academic Integrity*, the University Online Catalog, and the Student Code of Conduct, the following are examples of prohibited conduct. This list is not designed to be all-inclusive or exhaustive. In addition to academic sanctions, any student found to have committed academic misconduct that is also a violation of criminal law may also be subject to disciplinary review and action by the Office of Student Conduct (as outlined in the Student Code of Conduct).

#### Forms of Academic Dishonesty:

- <u>Cheating</u>: Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
- 2. <u>Plagiarism</u>: Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;
- 3. <u>Collusion</u>: When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
- 4. Conspiracy: Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and
- 5. <u>Multiple Submission</u>: Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.

#### PV's General Statement on the Use of Generative Artificial Intelligence Tools in the Classroom

Generative Artificial Intelligence (GAI), specifically foundational models that can create writing, computer code, and/or images using minimal human prompting, are increasingly becoming pervasive. Even though ChatGPT is one of the most well-known GAIs currently available, this statement includes any and all past, current, and future generations of GAI software. PVAMU expects that all work produced for a grade in any course, be it face-to-face or virtual, will be the sole product of a student's endeavors to meet those academic goals. However, should an instructor permit their students to use artificial intelligence as a resource or tool, students must not substitute the substance of their original work with the results of using such GAI tools. This clearly violates the <u>University's Administrative Guidelines on Academic Integrity</u> and its underlying academic values.

#### Nonacademic Misconduct

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the ability of other students to profit from the instructional program, or (3) campus behavior that interferes with the

rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

#### **Sexual Misconduct**

Sexual harassment of students and employees at Prairie View A&M University is unacceptable and will not be tolerated. Any member of the university community violating the university's sexual harassment policy will be subject to disciplinary action. In accordance with the Texas A&M University System guidelines, your instructor is obligated to report to the Office of Title IX Compliance (titleixteam@pvamu.edu) any instance of sexual misconduct involving a student, which includes sexual assault, stalking, dating violence, domestic violence, and sexual harassment, about which the instructor becomes aware during this course through writing, discussion, or personal disclosure. #### **Class Attendance Policy (See the University Online Catalog for Full Attendance Policy)**

Prairie View A&M University requires regular class attendance. Attending all classes supports the full academic development of each learner, whether classes are taught with the instructor physically present or via distance learning technologies such as interactive video and/or the Internet. Excessive absenteeism, whether excused or unexcused, may result in a student's course grade being reduced or in the assignment of a grade of "F." Absences are accumulated beginning with the first day of class during regular semesters and summer terms. Each faculty member will include the University's attendance policy in each course syllabus.

#### Makeup Work for Legitimate Absences

Prairie View A&M University recognizes that there are a variety of legitimate circumstances in which students will miss coursework and that accommodations for makeup work will be made. If a student's absence is **excused**, the instructor must either provide the student an opportunity to make up any quiz, exam, or other work contributing to the final grade or provide a satisfactory alternative by a date agreed upon by the student and instructor. Students are encouraged to work with instructors to complete makeup work before known scheduled absences (University-sponsored events, administrative proceedings, etc.). Students are responsible for planning their schedules to avoid excessive conflicts with course requirements.

#### Absence Verification Process

All non-athletic absences (e.g., Medical, Death/Funeral, Court/Legal-related, etc.) for which a student seeks to obtain a valid excuse must be submitted to the Dean of Students/Office of Student Conduct, with supporting documentation, for review and verification. Please use the <u>Online Reporting Forms</u> to access/complete/submit the *Request for a University Excused Absence* form for an excuse. Upon receipt, a staff member will verify the documentation and provide an official university excuse, if applicable. The student is responsible for providing the official university excuse issued by the Office for Student Conduct to the

#### **Student Academic Appeals Process**

Authority and responsibility for assigning grades to students rest with the faculty. However, in those instances where students believe that miscommunication, errors, or unfairness of any kind may have adversely affected the instructor's assessment of their academic performance, the student has a right to appeal by the procedure listed in the University Online Catalog and by doing so within thirty days of receiving the grade or experiencing any other problematic academic event that prompted the complaint.

#### Participants should have a basic proficiency of the following computer skills:

- Sending and receiving email
- A working knowledge of the Internet
- Microsoft Word (or a program convertible to Word)
- Acrobat PDF Reader
- Windows or Mac OS
- Video conferencing software (Zoom)

#### *Netiquette* (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

#### **Video Conferencing Etiquette**

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. Before the class session begins, test audio, video, and lighting to alleviate technology issues.

#### **Technical Support**

#### **Communication Expectations and Standards**

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

#### **Discussion Requirement**

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized using the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.

#### COVID-19 Campus Safety Measures

In accordance with the latest guidelines from the PVAMU Health Services, the following measures are in effect until further notice.

- Students who are ill will be asked to adhere to best practices in public health, such as masking, handwashing, and social distancing, to help reduce the spread of illness across campus.
