If a student has stopped attending the course (i.e. "stopped out") at any point after the first day of class but did not officially withdraw from the course and has missed assignments and exams and performed below the grade level of a D, a grade of FN (failed-non attendance) will be assigned for the final course grade to ensure compliance with the federal Title IV financial aid regulations. In contrast, if the student has completed all assignments and exams, but performed below the grade level of a D, a grade of F will be assigned for the final course grade.

Assignment Title

Description

1. Exams (Altogether = 80% of final course grade)

There will be four (4) exams in the course. The first 3 exams are worth 25 percent each. The lowest score between exams 1-3 will be dropped. The final exam is worth 30 percent and you cannot drop the final exam score. Exams will consist of a combination of multiple choice, short answer, and true/false questions. Exams are closed book, closed notes. Using notes, the book, and outside sources (internet or AI, such as ChatGPT, for example) on exams will be considered cheating and lead to an automatic 0 for the exam and the instructor reserves the right to assign a failing final grade to any student caught cheating. Exams should be taken as scheduled. Only students with a legitimate and documented reason for missing a scheduled exam will be allowed to take a makeup. Students who cannot take an exam must do everything possible to notify the instructor before the scheduled examination. Students have until 5:00pm on the date of the exam to call or email the instructor to apply for a makeup exam. Failure to do so will result in the makeup exam being denied. Make-up exams will be handled on a case-by-case basis for excused absences or documented emergencies and must be done within one week of the original exam unless circumstances require otherwise (See Student Handbook). Make up exams may be a modified version of the original exam. Failure to take an exam will result in a failing grade in the course. Exams are NOT cumulative.

2. Writing Assignment #1 (10% of final course grade)

Students must submit a research paper on how judges are selected in the Texas judiciary. Your paper must meet the following content, format and submission requirements:

CONTENT REQUIREMENTS

- 1. Identify and explain the current TEXAS law regarding the selection of most judges in Texas.
- 2. Identify and explain at least two other types of judicial selection processes used in the U.S.
- 3. Choose whichever judicial selection method you think is best and give at least two criteria explaining how and why you made your choice. Possible criteria include: impartiality/independence,

- accountability and competence of judges.
- 4. Describe who may or may not benefit from the position you take in 3) above. Consider the impact on political parties, on justices and the individuals in the Texas court system. Also consider the impact in other areas, e.g., economic, political, social.
- 5. List at least two things you could do in order to engage the political process in Texas in pursuit of your position in 3) above, be specific.
- 6. Cite at least three (3) reliable, quality references within the body of the paper using the Chicago Manual of Style's Author/Date parenthetical citation style. One of the citations MUST come from the class textbook (-10 points if this is not done). You must have at least three parenthetical citations in the body of the paper that correctly match the sources properly formatted in the Works Cited Page.

A paper with no parenthetical source citations in its body will receive a grade of 0.

A paper with no works cited section (a.k.a. list of reference list, a.k.a. bibliography) at the end of the body will receive a grade of 0.

A significant penalty (30 points) will be given if sources listed in the works cited cannot be found in the paper itself (or if sources listed in the paper cannot be found in the Works Cited).

FORMAT REQUIREMENTS:

- 1. Typed, 2-3 pages (not counting Works Cited Page), 12-point font, double-spaced.
- 2. Your name, my name, POSC 2306, and the date.
- 3. A title is required, but a separate title page is not necessary.
- 4. A thesis or statement of purpose in the first paragraph, e.g., "This paper will..."
- 5. Use of the Chicago Manual of Style's Author Date parenthetical citation format. Students must be very careful and pay attention to details when they examine and cite internet sources. The university and political science program policies on plagiarism will be strictly enforced unacknowledged quotation and/or paraphrase of someone else's words, ideas, or data as one's own in work submitted for credit is plagiarism. Failure to identify information or essays from the Internet and submitting them as one's own work also constitutes plagiarism (see university policy). The minimum penalty for plagiarism is an F for the assignment and/or an F for the course. Examples for the Chicago citation format can be found here:

- 6. Use of footnotes or endnotes is prohibited.
- 7. Using encyclopedias, like Wikipedia, history.com, kids.law.com is prohibited (-10 points).
- 8. Use of word mixers like Spinbot or Al like ChatGPT are prohibited

and will result in a grade of 0; no second chances will be allowed. The expectation is that this paper will be written in YOUR words – this is not an exercise in copy/paste and you should only use direct quotes when it is absolutely necessary (with correct citation).

SUBMISSION REQUIREMENTS

- Your paper must be submitted online in Canvas/E-Courses by March 26th at 8:00pm. Papers must be in either Word or PDF format. Papers that cannot be opened will receive a 0.
- 2. Late submissions will not be accepted under any circumstances, so plan accordingly.
- 3. A paper placed in my office, in my mailbox or emailed will not be accepted for grading.

Papers are graded according to the following four criteria: 1) content; 2) organization; 3) quality of writing; and 4) quality of research sources and reference citation formats.

3. Plagiarism Test Certification (10% of final course grade) Students are required to register for, then take this 10-question Plagiarism Certification Test as many times as necessary in order to obtain the Plagiarism Certificate. Submit the Plagiarism Certificate to receive full credit (100 points) for this assignment. Click here if the hyperlink above does not work:

- Submit the Plagiarism Certificate in Word or PDF format on Canvas/E-Courses no later than 8:00pm on January 25th. Assignments that cannot be opened will receive a 0. You are welcome to turn in the assignment any time before the deadline. Make sure your submission has both the Test ID and IP address for verification purposes.
- 2. Late submissions will not be accepted under any circumstances, so plan accordingly.

Additional Instructor Policies Class Rules and Other Key Information:

- 1. Email: You should put your name on all email correspondence. I will NOT send exam, quiz, assignment and final grades via email. You may receive your grades when exams, etc., are posted online, or you may drop by my office hours to receive your grades and other pertinent material. Requests for grade checks or academic progress reports will only be signed in my office so prepare accordingly.
- 2. In order for you to receive an excused absence, you **must** notify me **prior** to class; or you **must** have a documented emergency or school sponsored activity; otherwise, all absences and tardies will be considered unexcused. Oversleeping, exams in other classes, and things of that nature are not considered emergencies. Please see the Student Handbook for more information on attendance policies and excused absences.
- 3. E-Courses will be utilized to post grades and for communication between me and the class. Students are responsible for all announcements made in class or any changes in the schedule.
- 4. Respectful class and student behavior is expected at all times this includes, but is not limited to treating the

professor and other classmates respectfully, asking questions when needed, practicing academic honesty, etc. Failure to do so will result in a 5-point deduction of your overall class average for each infraction.

5. Students are expected to do their own work. Collaboration is an important part of the learning process and the professor wants you to engage in class discussion or work together for things like study groups BUT all written assignments/exams are expected to be YOUR OWN WORK. Failure to respect this rule will be considered cheating and academic dishonesty – resulting in a minimum of taking a 0 for the assignment and/or an F for the course. When in doubt or if you have questions – feel free to see the professor and students are expected to improper behavior immediately.

Political Science Program Policy on Plagiarism: Plagiarism is a serious academic crime and the Political Science Program has a strict, rigorous enforcement policy for students who commit plagiarism. In general, plagiarism is using another person's words, statistics, and/or ideas as if they were your own. Plagiarism, which is formally defined in the University Rules and Procedures section of this syllabus, can come in many forms, such as directly quoting a source without quotation marks, directly quoting a source without giving a reference citation, paraphrasing a source without giving a reference citation and so forth. It is incumbent on students to seek help from the instructor or other University resources to avoid even the appearance of plagiarism in their work. Any student caught committing ANY type of plagiarism in a Political Science course will receive one OR MORE of the following punishments, depending on the severity of the offense and in accordance with the Student Code of Conduct:

- 1. Grade Penalty (an F for the assignment and/or an F for the course);
- 2. Letter of Reprimand
- 3. Probation
- 4. Suspension
- 5. Dismissal from Academic Program
- 6. Expulsion from the university.

Electronic Communication Policy: Course materials are posted on Canvas/eCourses, which is available at http://ecourses.pvamu.edu. You are expected to use this website as a resource for the class. The University also maintains an email account for you. I may send you notices so I expect you to check your Prairie View A&M email account and Canvas/E-Courses at least once a day. If you have problems accessing your account, call (936) 261-2525. Failure to access your Panther Email or Canvas/E-Courses is not an excuse for missing important information.

Make-up Policy: You will only be allowed to make up an exam if you have a valid excuse. Students should make every effort to inform the instructor in advance of missing an exam. Beyond documented valid excuses, there will be no makeup exams given. If granted a make-up, you have a period of one week (from the date of the missed event) to complete a make-up exam. After that point, the grade becomes a zero. Please provide written documentation for why you need to make-up an exam (Note from University Official, Doctor, Police Officer, Coach, and Parent). Student athletes must notify me BEFORE they attend an event to represent the school and MUST be proactive in getting their exams completed. Make up exams may be a modified version of the original exam. Make-ups will always be given during office hours. Failure to comply with these rules will mean a five-point reduction in your overall class average for each infraction.

Grade Groveling and Grade Appeal Policy: Students concerned about their grades should endeavor to attend all class sessions and complete all work to the best of their ability. Students earn high grades, based on demonstrating mastery of the subject matter and not based on what they want or need for their overall GPA. Therefore, no grade groveling will be entertained and no "do-overs" allowed. Students have one week (from the date the assignment or exam grade was handed back in class or posted on E-courses) to challenge the grade and do so in writing/email. The instructor will regrade the entire assignment so the final grade can improve, be lowered, or remain the same. When challenging a grade, it is the responsibility of the student to produce the requisite materials.

Academic Misconduct

Forms of Academic Dishonesty:

- 1. <u>Cheating</u>: Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
- 2. <u>Plagiarism</u>: Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;
- 3. <u>Collusion</u>: When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
- 4. Conspiracy: Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and
- 5. <u>Multiple Submission</u>: Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.

PV's General Statement on the Use of Generative Artificial Intelligence Tools in the Classroom

Generative Artificial Intelligence (GAI), specifically foundational models that can create writing, computer code, and/or images using minimal human prompting, are increasingly becoming pervasive. Even though ChatGPT is one of the most well-known GAIs currently available, this statement includes any and all past, current, and future generations of GAI software. PVAMU expects that all work produced for a grade in any course, be it face-to-face or virtual, will be the sole product of a student's endeavors to meet those academic goals. However, should an instructor permit their students to use artificial intelligence as a resource or tool, students must not substitute the substance of their original work with the results of using such GAI tools. This clearly violates the <u>University's Administrative Guidelines on Academic Integrity</u> and its underlying academic values.

Nonacademic Misconduct

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the ability of other students to profit from the instructional program, or (3) campus behavior that interferes with the rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

Sexual Misconduct

Sexual harassment of students and employees at Prairie View A&M University is unacceptable and will not be tolerated. Any member of the university community violating the university's sexual harassment policy will be subject to disciplinary action. In accordance with the Texas A&M University System guidelines, your instructor is obligated to report to the Office of Title IX Compliance (titleixteam@pvamu.edu) any instance of sexual misconduct involving a student, which includes sexual assault, stalking, dating violence, domestic violence, and sexual harassment, about which the instructor becomes aware during this course through writing, discussion, or personal disclosure. Class Attendance Policy (See the University Online Catalog for Full Attendance Policy)

Prairie View A&M University requires regular class attendance. Attending all classes supports the full academic development of each learner, whether classes are taught with the instructor physically present or via distance learning technologies such as interactive video and/or the Internet. Excessive absenteeism, whether excused or unexcused, may result in a student's course grade being reduced or in the assignment of a grade of "F." Absences are accumulated beginning with the first day of class during regular semesters and summer terms. Each faculty member will include the University's attendance policy in each course syllabus.

Makeup Work for Legitimate Absences

Prairie View A&M University recognizes that there are a variety of legitimate circumstances in which students will miss coursework and that accommodations for makeup work will be made. If a student's absence is **excused**, the instructor must either provide the student an opportunity to make up any quiz, exam, or other work contributing to the final grade or provide a satisfactory alternative by a date agreed upon by the student and instructor. Students are encouraged to work with instructors to complete makeup work before known scheduled absences (University-sponsored events, administrative proceedings, etc.). Students are responsible for planning their schedules to avoid excessive conflicts with course requirements.

Absence Verification Process

All non-athletic absences (e.g., Medical, Death/Funeral, Court/Legal-related, etc.) for which a student seeks to obtain a valid excuse must be submitted to the Dean of Students/Office of Student Conduct, with supporting documentation, for review and verification. Please use the Online Reporting Forms to access/complete/submit the Request for a University Excused Absence form for an excuse. Upon receipt, a staff member will verify the documentation and provide an official university excuse, if applicable. Student Academic Appeals Process

Authority and responsibility for assigning grades to students rest with the faculty. However, in those instances where students believe that miscommunication, errors, or unfairness of any kind may have adversely affected the instructor's assessment of their academic performance, the student has a right to appeal by the procedure listed in the

University Online Catalog and by doing so within thirty days of receiving the grade or experiencing any other problematic academic event that prompted the complaint.

* Some courses may require remote proctoring. At this time only Chromebooks, laptops, and desktops running Windows or Mac work with our proctoring solution, but iPads are not compatible. Most other applications will work with Android or Apple tablets and smartphones.

Participants should have a basic proficiency of the following computer skills:

- Sending and receiving email
- A working knowledge of the Internet
- Microsoft Word (or a program convertible to Word)
- Acrobat PDF Reader
- Windows or Mac OS
- Video conferencing software (Zoom)

Netiquette (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

Video Conferencing Etiquette

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. Before the class session begins, test audio, video, and lighting to alleviate technology issues.

Technical Support

Communication Expectations and Standards

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

Discussion Requirement

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized using the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.

COVID-19 Campus Safety Measures

In accordance with the latest guidelines from the PVAMU Health Services, the following measures are in effect until further notice.

- Students who are ill will be asked to adhere to best practices in public health, such as masking, handwashing, and social distancing, to help reduce the spread of illness across campus.
