

PVAMU COMMEMORATES 135TH ANNIVERSARY OF THE SECOND MORRILL ACT

Prairie View A&M University scholars available to provide expert insight on historic legislation and its ongoing impact.

PRAIRIE VIEW, Texas (August 29, 2025) - Prairie View A&M University is marking the 135th anniversary of the Second Morrill Act of 1890, landmark legislation that required states to establish land-grant institutions for Black students. The Act led directly to the designation of Prairie View A&M and 18 other historically Black colleges and universities as land-grant institutions, forever shaping the landscape of higher education.

PVAMU will commemorate this occasion by offering expert analysis and commentary from distinguished faculty who can speak to the history, significance, and continuing influence of the Act. This effort is part of an ongoing oral history project to preserve perspectives from an institution that has benefitted profoundly from the legislation.

Available Experts Include:

- Dr. Melanye Price Expertise in Political Science, African American Studies, and Race and Justice. She also serves as co-chair of the prestigious Ruth J. Simmons Center for Race and Justice. Dr. Price can address the Morrill Act's significance within broader struggles for access, justice, and equity in higher education.
- Dr. Marco Robinson A historian specializing in African American and Texas history, Dr. Robinson can contextualize the 1890 Act's passage and PVAMU's role in shaping opportunities for generations of students.
- Dr. Bequita Pegram Expertise in African American History (Cultural Heritage, Civil Rights, and Community Preservation) and U.S. History (Social, Cultural, and Educational Developments). Dr. Pegram can speak to how these legacies inform community identity, historical preservation, and the continuing struggle for educational equity.
- Dr. Tiffany Thomas An expert in urban planning and public policy, Dr. Thomas can connect the Morrill Act's emphasis on access to the ongoing need for inclusive educational policy and community development.

Why This Matters:

The Second Morrill Act not only secured PVAMU's future as a land-grant university but also expanded the promise of higher education to African Americans at a time when opportunities were systematically denied. Today, PVAMU fulfills the land-grant mission of teaching, research, and Extension, with programs that empower communities across Texas and beyond.
