

# Master of Business Administration Program

The Master Business Administration (MBA) is a professional graduate degree offered by the College of Business at Prairie View A&M University. Students of the program develop a broad understanding of the various aspects and dimensions of a business organization. Once completed, graduates of the program have the analytical skillset needed to make strategic decisions for the benefit of the business enterprise.

## **Program Details**

Students enrolled in the MBA program must complete 36 graduate credit hours of coursework, including nine (9) required courses (listed below) and three (3) elective courses (elective options listed on your degree plan).

Students can complete core classes in either face-to-face or online formats. Each face-to-face class meets at Prairie View A&M's NW Houston Campus one night a week from 6:00 to 8:50 pm. Online classes may occur in real-time or be self-paced. Students seeking to complete the degree in a particular format should work with the Graduate Director to help develop a schedule that meets the student's needs.

Students choose three (3) elective courses from an approved inventory of business courses. Depending on the combination of courses, a student has the option of completing one of four concentrations or pursuing a general plan.

Please speak with Graduate Director for questions about the instructional format of certain elective courses.

- -Accounting Concentration (Advanced Auditing, Seminar in Tax, Data Analytics in Accounting)
- -Entrepreneurship Concentration (Managing Innovation, Leading Innovation, Funding New Ideas)
- **-Finance Concentration** (Investment Analysis & Management, Financial Markets and Institutions, Special Topics in Finance)
- -Management Information Systems Concentration (Applied Database Management, Information System Analysis & Design, Special Topics in MISY)
- **-General Management Concentration** (three approved graduate business electives from course inventory)

## **Program Prerequisites**

Individuals seeking to enroll in the MBA program must have earned a four-year baccalaureate degree. Those individuals not holding a four-year degree in business must complete a series of prerequisite courses (or have previously completed undergraduate equivalents) in order to move into core courses for the program. A grade of 'C' or better is required for each prerequisite. Upon review of transcripts submitted with the program application, the Graduate Director will determine whether prerequisites need to be assigned or can be waived.

#### **Program Admission Application Requirements**

- Four-year baccalaureate degree from accredited institution. Overall undergraduate GPA of 2.5 or above.
- Complete and submit university's Graduate Studies application online, along with application fee.
- Three recommendations from current or former managers/supervisors, former professors, co-workers or other individuals with professional affiliation. [Please use Graduate Studies recommendation form.]
- Response to essay question: *Please share your short-term and long-term career goals. Explain how the graduate business degree contributes to accomplishing these goals.*
- Updated professional resume is optional, but **strongly** recommended.
- Applicant Information Form (available in Application Checklist document)

#### **Frequently Asked Questions**

Is the GMAT or GRE required for the program? No! There is no test requirement for the MBA Program.

*Is the MBA degree at PVAMU accredited?* Yes! The Association to Advance Collegiate Schools of Business (AACSB) accredits all undergraduate and graduate degrees offered by the College of Business at Prairie View A&M University. That includes the MBA Program.

How long does it take to earn the MBA degree? The program at Prairie View A&M is considered a part-time MBA Program. On average, students who were business majors can complete the degree in approximately two (2) years. For non-business majors, the average time to completion is three years.

Being a self-paced program, some students may enroll either full-time (three graduate classes) or part-time (one to two graduate classes) in the Fall or Spring semesters. Some classes are also available in the Summer term as well. The number of classes you enroll in helps determine the time to completion.
