6. If I fail to meet the minimum qualifications (3.0 GPA) my scholarship may be forfeited, if satisfactory progress is not made.
7. I understand the scholarship will be forfeited in the event I am suspended from the University for violating the University's disciplinary code.
8. If I use false information to obtain the scholarship, the scholarship may be forfeited and I may be required to repay all monies received.
9. I may not receive a notice of current scholarship status, but I will be responsible for adhering to the written scholarship agreement during my tenure on scholarship.
10. I will participate in Panther Pipeline Program organized scholarly activities.
