**Catalog Description:** A writing course that emphasizes rhetorical analysis and critical thinking, advanced research and documentation, and writing extended arguments for academic audiences. Students will actively participate in peer workshops and demonstrate an awareness of academic research methods and ethics.

**Prerequisites:** Completion of ENGL 1123 or transfer equivalent with a "C" or better  
**Co-requisites:** n/a

**Required Texts:** LaunchPad for *Everything's an Argument, With Readings*, 7<sup>th</sup> ed. Bedford/St. Martin's. Other course materials are posted on eCourses.

**Course Goals:** Goals of this course include continuing to develop skills learned in Composition I, with emphasis on formal academic writing; producing argumentative writing based on close analysis of primary and secondary source material; improving a sense of audience in reading and writing; mastering techniques for research and documentation; and writing at least 3 papers with a research component.

### Detailed Description of Major Assignments:

Exams	Multiple choice examinations demonstrating mastery of course content
Essays	Formal essays demonstrating ability to produce college-level, research-based analytical writing. Essay #3 requires students to develop a complex, evidence-based argument using a variety of academic and non-academic sources.
Prewriting Assignments	Assignments demonstrating engagement in writing as a recursive process
Group Assignment	Project demonstrating effective teamwork and critical thinking.

### Course Procedures

#### Taskstream

Taskstream is a tool that Prairie View A&M University uses for assessment purposes. At least one of your assignments is **REQUIRED** to be submitted as an "artifact," an item of coursework that serves as evidence that course objectives are met. More information will be provided during the semester, but for general information, you can visit Taskstream via the link in eCourses.

**Submission of Essays:** All essays and prewriting assignments must be submitted through Turnitin.com by the deadline posted within the system. If your instructor also requires a hard copy, printed essays are due at the beginning of the class period. Essays will be accepted late for four days after the due date with a deduction of 5% from your essay grade for each day. After four days have passed, your essay will not be accepted and you will receive a grade of zero on the assignment.

Be advised that Turnitin.com checks all submissions for plagiarism against web sources, periodical archives, and other student submissions. Access to Turnitin.com is free. Create a new account or sign in using an existing account at: [http://www.turnitin.com/en\\_us/home](http://www.turnitin.com/en_us/home). Use the Class ID number and course key provided elsewhere by your instructor to enroll in the proper section of the course. Do not enroll into the class more than once. The Class ID is unique to your section of this course; so, you will not receive credit for your work if you enroll using a Class ID for another section.

**\*\*\*NOTE:** All of your work for this course must be original to you and to the course. You are not allowed to submit papers that you or anyone else has submitted for any other course or any other previous or concurrent section of composition.

**Exam and Quiz Policy:** The midterm and final exams should be taken as scheduled. No makeup exams will be allowed unless there is a documented emergency (see Student Handbook). If you have a university event on the day of the exam, arrange to take it early. Throughout the semester, pop quizzes over textbook readings and course concepts may be given. If you are late or do not have an excused absence, you cannot make up a quiz. With an excused, documented absence from a legitimate third party, you may make up a quiz at the instructor's convenience.

**Extra Credit Policy:** No extra credit will be available in any section of Composition or Technical Writing.

**All papers are submitted online through eCourses.** Students MUST keep copies of all submitted work in case the instructor does not receive it. Store all papers until the end of the following long semester. Remember that computers break down. Keep backup copies of your work.// All papers must be submitted as .rtf, .pdf .doc, .docx

**Absolutely no essays in .pages format will be read or accepted!**

Submitting papers online means that page breaks and headers must be created using the computer not by spacing. As you begin the class, take the time to go to Help within your word processor. Check the process for creating these elements in a paper: Headers in the header screen, page breaks, Hanging Indents for the Works Cited in MLA format.

**Attendance:** You have 3 absences, no questions asked. After the 4<sup>th</sup> absence your daily participation grade is reduced by a letter grade. After the 5<sup>th</sup> absence your participation grade becomes a zero. After the 6<sup>th</sup> absence you will **automatically fail the course.**

Do not use YOU or I in formal writing. Papers – other than journals -- using YOU or I or versions thereof will have significantly reduced grades. Write your papers in third person plural nouns. For example, instead of saying, “When you go to the store . . . ,” say “When **consumers** go to the store,” or “When **people** go to the store, they . . .” Instead of saying, “I think that the world is round,” say “The world is round.” We know the second statement is your opinion because your name is on the assignment.

**\*\*\*NOTE:** All of your work for this course must be original to you and to the course. You are not allowed to submit papers that you or anyone else has submitted for any other course or any other previous or concurrent section of composition.

All essays must be submitted through eCourses. ABSOLUTELY NO EMAIL OR HARDCOPY SUBMISSIONS WILL BE ACCEPTED. If you encounter any technical difficulties with either eCourses or any computer or internet troubles, it is up to you and you alone to fix it. I have no power over technology.

**ANY ESSAY WITH LONG SECTIONS LACKING QUOTES/CITATIONS OR MISSING A WORKS CITED PAGE WILL BE CONSIDERED TO HAVE UNINTENTIONAL PLAGIARISM AND WILL RECEIVE A ZERO! NO EXCEPTIONS!**

***Communication Expectations and Standards:***

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

***Discussion Requirement:***

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can take place in a seminar fashion. This will be accomplished by the use of the discussion board. The exact use of discussion will be determined by the instructor.

**It is strongly suggested** that students type their discussion postings in a word processing application and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized by the use of the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, it/they should be copied and pasted to the discussion board.
