Detailed Description of Major Assignments: (Consult the Calendar below for all due dates!)

Assignment Title or Grade Requirement	Description
1. Exams (Altogether = 450 points)	<u>Three non-cumulative multiple-choice</u> exams will contain approximately 50 questions, respectively, and may be held online and may require use of the LockDown Browser (consult your instructor). The following campus facilities offer access to it: JB Coleman Library (rooms 210 and 210B and the Student Success Center on the third floor), MSC (1 st floor main lab), Farrell Hall (1 st floor main lab), Delco (room 301), Hobart Taylor (room 1A109), and E.E. O’Banion (“New”) Science (room 123). No makeup is allowed unless there is a University-verified emergency (refer to the make-up policy & absence/excuse verification process in the policy section). Exam #1 (Chs.1-4) & Exam #2 (Chs.5-8) will be worth 165 points, respectively, and Exam #3 (Chs.9&12-13) 120 points.
2. InQuizitive quizzes (220 points)	Your textbook comes with an interactive feature called “InQuizitive.” You are required to answer all these questions. Unlike the actual exams, you can retake these quizzes as many times as you like. You will take 11 InQuizitive sets and each quiz will be worth 20 points.
3. Essay Assignments (160 points)	Students are required to complete two essay assignments, which will be worth 80 points, respectively. <u>Please go over my detailed instructions</u> and rubric on these assignments on our Canvas website and <u>check your assignment due dates</u> . Essay #1 will address political history & civic engagement, and Essay #2 voting and elections. Both essays will have AfAm-designation components.
4. Writing Assignment (120 points)	Prompt: The Texas government confronts many issues that deeply divide public opinion. State government’s policy responses to issues like abortion, crime, education, border security, energy (the electric grid, for example), voting, etc., can satisfy some while

angering others. This assignment asks you to explore a public policy issue of your choice and complete the following content, format and submission requirements:

CONTENT REQUIREMENTS:

1. Choose an issue in Texas Politics, such as the ones listed above or another issue (with approval) and explain why you chose this topic in a couple of sentences.
2. Use an AI tool to generate output that presents at least two sides regarding your issue, e.g., for/against more gun control or for/against abortion rights. Explain which AI you used, why you chose that AI, and then summarize the AI's output on both sides of your issue.
3. Conduct your own research on the issue that extends, broadens, or deepens the AI's output. Point out how your analysis is different/better than what the AI produced.
4. Explain which side of the debate you take on this issue and why. Make sure your explanation extends beyond what you did for item 3.
5. Explain at least two ways you would engage or participate in the state political process to advocate for your position. (10 points)
6. Make at least two predictions regarding your issue. Will one side prevail, and how will this issue impact the upcoming state elections (for Governor, State legislature, etc.)? What law might the Texas Legislature pass in the future, or what policy might the Texas Governor or state agencies implement? Explain why you make these two predictions.
7. Cite at least three (3) scholarly references within the body of the paper using the Chicago Manual of Style's parenthetical citation style. A parenthetical citation must include the author's last name, year of publication (or date accessed if publication date is not available), and the page number if available, such as: (Smith 2023, 421). One of the parenthetical citations MUST come from the class textbook. Include a properly formatted Works Cited Page.

A paper with no parenthetical source citations in its body will receive a grade of 0.

A paper with no works cited section (a.k.a. list of reference list, a.k.a. bibliography) at the end of the body will receive a grade of 0.

FORMAT REQUIREMENTS:

1. Typed, 2-3 pages (not counting Works Cited Page), Times New Roman. 12-point font, double-spaced.
2. Your name, my name, POSC 2306, and the date.
3. A title is required, but a separate title page is not necessary.
4. An introduction with a thesis/statement of purpose in the first paragraph: "This paper will..."
5. A logically organized and sequenced body followed by a clearly stated conclusion.
6. Use of the [Chicago Manual of Style's parenthetical citation format](#). Students must be very careful and pay attention to details when they examine and cite internet sources.
7. **Use of footnotes or endnotes is prohibited.**
8. **Using encyclopedias, like Wikipedia, Ballotpedia, history.com, kids.law.com, etc. is prohibited (-10 points).**
9. **Use of word mixers like Spinbot is prohibited and will result in a grade of 0; no second chances will be allowed.** Also, see the statements below regarding academic integrity, plagiarism, and generative artificial intelligence, such as ChatGPT.

SUBMISSION REQUIREMENTS

1. Your paper must be submitted in eCourses. You do NOT need a code; log into eCourses and click on the link that says, "Writing Assignment," then click on the submission tab and follow the prompts to upload your paper.

	<p>2. Late submissions will not be accepted more than four days after the deadline, so plan accordingly (refer to my late/tardy policy).</p> <p>3. A paper placed in my office, in my mailbox or emailed will not be accepted for grading.</p> <p>Papers are graded according to the following four criteria: 1) content; 2) organization; 3) quality of writing; and 4) quality of research sources and reference citation formats. <u>Students are highly recommended to visit the Writing Center before they turn in their papers (extra credit will be given).</u></p>

6. Class Contract & Syllabus Quiz (25 points)	Students are required to sign the class contract and complete the syllabus quiz in order to be part of this class. In the first week, please go over all the information provided in the syllabus and the class contract to perform well in this course. If students do not accept the terms and conditions listed in the class contract, they are advised to change to a different class. The class contract is valid through the end of the semester.
7. Extra Credit Assignments (up to 3% of final course grade)	There will be several extra credit assignments throughout the semester. One example is to write a reaction paper about what you learned from the activities (simulations, games, or films) we did in class.

Course Procedures or Additional Instructor Policies

Attendance Policy: This course will be asynchronous (i.e., we are not meeting in person or virtually). I will upload weekly course materials on Canvas every Monday morning. It is your responsibility to follow the class schedule. Please try to keep up with the schedule, stated in the syllabus.

Late/Tardy Policy: 1) Assignments: No extensions will be allowed (with the exception of extraordinary cases in which prior instructor’s consent is required before the deadline for the assignment). Students who do not submit their work on time will be penalized 10% of the maximum points for each day they do not submit their work. Work that is submitted **four** days or more after the deadline will receive a grade of zero for the assignment. The due dates of assignments are clearly marked in the course schedule, and it is your responsibility to know when assignments are due. 2) I do not accept late extra credit assignments.

Make-up Policy: You will only be allowed to make up an exam or assignment if you have a valid excuse. Valid excuses include documented illness, school or business trips, or family crises. Without proper documentation, there will be no makeup assignments. To verify your absence (or make-up excuses), please follow the University's official instructions below. 3) All course materials will be posted on Canvas, which is available at <http://ecourses.pvamu.edu>. You are expected to use this website as a resource for the class; in particular, the weekly agenda page of every module should be the starting point. I expect you to check the weekly agenda page (under the Modules tab) **every Monday afternoon at the latest**, since I will post it every Monday morning. In terms of important announcements, I post them under the Announcements tab on Canvas but I also send them via email/message. So, I expect you to check your PVAMU email account at least once a day.

4) It usually takes for me to respond to your emails approximately one-two business days. Political Science Program Policy on Plagiarism: Plagiarism is a serious academic crime and the Political Science Program has a strict, rigorous enforcement policy for students who commit plagiarism. In general, plagiarism is using another person's or artificially generated program's words, statistics, and/or ideas as if they were your own. Plagiarism, which is formally defined in the University Rules and Procedures section of this syllabus, can come in many forms, such as directly quoting a source without quotation marks, taking another student's work, directly quoting a source without giving a reference citation, paraphrasing a source without giving a reference citation and so forth. It is incumbent on students to seek help from the instructor or other University resources to avoid even the appearance of plagiarism in their work. If in doubt, CITE THE SOURCE! Any student caught committing ANY type of plagiarism in a Political Science course will receive one OR MORE of the following punishments, depending on the severity of the offense and in accordance with the Student Code of Conduct:

1. Grade Penalty (an F for the assignment or for the course) in addition to cancellation of any extra credit points
2. Letter of Reprimand
3. Probation
4. Suspension
5. Dismissal from Academic Program
6. Expulsion from the university.

Students must consult the University's Code of Conduct for other forms of academic dishonesty and punishments.

Netiquette (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussions boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such

as “wassup?” and texting abbreviations such as “u” instead of “you.” Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post and the message might be taken seriously or sound offensive.

Video Conferencing Etiquette

When using Zoom, WebEx or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during session. Before class session begins, test audio, video and lighting to alleviate technology issues.

Grade Groveling Policy: Students concerned about their grades should endeavor to attend all class sessions and complete all work to the best of their ability. Students **earn** high grades, based on demonstrating mastery of the subject matter and not based on what they want or need for their overall GPA. Therefore, no grade groveling will be entertained and no “do-overs” allowed.

University Rules and Procedures

Academic Misconduct

Academic dishonesty is defined as any form of cheating or dishonesty that has the effect or intent of interfering with any academic exercise or fair evaluation of a student's performance. The college faculty can provide additional information, particularly related to a specific course, laboratory, or assignment.

You are expected to practice academic honesty in every aspect of this course and all other courses. Make sure you are familiar with the *University Administrative Guidelines on Academic Integrity*, which can be found on the [Academic Integrity webpage](#). Students who engage in academic misconduct are subject to university disciplinary procedures. As listed in the *University Administrative Guidelines on Academic Integrity*, the University Online Catalog, and the Student Code of Conduct, the following are examples of prohibited conduct. This list is not designed to be all-inclusive or exhaustive. In addition to academic sanctions, any student found to have committed academic misconduct that is also a violation of criminal law may also be subject to disciplinary review and action by the Office of Student Conduct (as outlined in the Student Code of Conduct).

Forms of Academic Dishonesty:

1. **Cheating:** Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
2. **Plagiarism:** Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;
3. **Collusion:** When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
4. **Conspiracy:** Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and
5. **Multiple Submission:** Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.

PVAMU's General Statement on the Use of Generative Artificial Intelligence Tools in the Classroom

Generative Artificial Intelligence (GAI), specifically foundational models that can create writing, computer code, and/or images using minimal human prompting, are increasingly becoming pervasive. Even though ChatGPT is one of the most well-known GAIs currently available, this statement includes any and all past, current, and future generations of GAI software. Prairie View A&M University expects that all work produced for a grade in any course, be it face-to-face or virtual, will be the sole product of a student's endeavors to meet those academic goals. However, should an instructor permit their students to use artificial intelligence as a resource or tool, students must not substitute the substance of their original work with the results of using such GAI tools. This clearly violates the [University's Administrative Guidelines on Academic Integrity](#) and its underlying academic values.

Nonacademic Misconduct

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the ability of other students to profit from the instructional program, or (3) campus behavior that interferes with the rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

Sexual Misconduct

Sexual harassment of students and employees at Prairie View A&M University is unacceptable and will not be tolerated. Any member of the university community violating the university's sexual harassment policy will be subject to disciplinary action. Prairie View A&M University requires regular class attendance. Attending all classes supports the full academic development of each learner, whether classes are taught with the instructor physically present or via distance learning technologies such as interactive video and/or the Internet. Excessive absenteeism, whether excused or unexcused, may result in a student's course grade being reduced or in the assignment of a grade of "F." Makeup Work for Legitimate Absences

Prairie View A&M University recognizes that there are a variety of legitimate circumstances in which students will miss coursework and that accommodations for makeup work will be made. If a student's absence is **excused**, the instructor must either provide the student an opportunity to make up any quiz, exam, or other work contributing to the final grade or provide a satisfactory alternative by a date agreed upon by the student and instructor. Students are encouraged to work with instructors to complete makeup work before known scheduled absences (University-sponsored events, administrative proceedings, etc.). Students are responsible for planning their schedules to avoid excessive conflicts with course requirements.

Absence Verification Process

All non-athletic absences (e.g., Medical, Death/Funeral, Court/Legal-related, etc.) for which a student seeks to obtain a valid excuse must be submitted to the Dean of Students/Office of Student Conduct, with supporting documentation, for review and verification. Student Academic Appeals Process

Authority and responsibility for assigning grades to students rest with the faculty. However, in those instances where students believe that miscommunication, errors, or unfairness of any kind may have adversely affected the instructor's assessment of their academic performance, the student has a right to appeal by the procedure listed in the University Online Catalog and by doing so within thirty days of receiving the grade or experiencing any other problematic academic event that prompted the complaint.

Participants should have a basic proficiency of the following computer skills:

- A working knowledge of the Internet
- Microsoft Word (or a program convertible to Word)
- Acrobat PDF Reader
- Windows or Mac OS
- Video conferencing software (Zoom)

Netiquette (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

Video Conferencing Etiquette

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. Before the class session begins, test audio, video, and lighting to alleviate technology issues.

Communication Expectations and Standards

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

Discussion Requirement

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized by the use of the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.

COVID-19 Campus Safety Measures

In accordance with the latest guidelines from the PVAMU Health Services, the following measures are in effect until further notice.

- Students who are ill will be asked to adhere to best practices in public health, such as masking, handwashing, and social distancing, to help reduce the spread of illness across campus.
