Summary of Safety Rules

It may happen that you are confronted with a laboratory accident and cannot remember exactly what to do. In such a situation, just remember the following:

In the case of a spill: WASH!

In the case of a fire: GET OUT!

In either case, the instructor or someone in a calmer frame of mind can then decide how to handle the situation.

Personal Safety

(1i) Most laboratory safety precautions are nothing more than common sense. The laboratory is not the place for horseplay, pranks, or other acts of mischief in laboratories. Do not work alone in the laboratory. Do not perform unauthorized experiments. Never sniff, inhale (Vape tobacco products)) or taste laboratory chemicals. Never eat, drink, chew gum or tobacco, smoke or apply cosmetics in the laboratory. Report all accidents, no matter how minor

Know Emergency Procedures

Know where the nearest emergency eyewash and showers are how to use them.

Your own reference. Know at least two exists from the laboratory area in case of an emergency

Never remove chemicals from the laboratory without proper authorization

The Laboratory Notebook

A laboratory notebook serves several purposes. The first is for your own reference. You may think that you will remember everything you do and see in the laboratory; however, many details such as melting points, weights, and certain observations are easily forgotten. IT is far better to record these details in a well-organized notebook than to try to memorize them. An approved notebook should be used.

Another purpose of a laboratory notebook is to allow your instructor or lab partner to review your work, continue, or repeat it exactly. If a particular experiment does not work well for you or the group, the instructor would want to know why. Your detailed written procedure and observations can give clues to experimental failures.

The Correct or Approved Notebook

The correct notebook for the laboratory is a hardcover, bound book containing lined pages. These are readily available at bookstores or stationary section of dollar stores. A loose-leaf or spiral notebook is not satisfactory because pages are easily removed and lost. A separate or dedicated notebook is recommended for this course.

Keeping the Notebook

If the pages in the notebook are not numbered, number them before using the book.

Write your name and laboratory section number on the cover of your notebook.

Leave two blank pages in the front of the book for table of contents.

Enter experiments consecutively in ink, use permanent ink. Do not write in pencil.

Use only right-hand pages for writing up experiments. At the top of page, write the date on which the experiment is performed. Each experiment in the notebook should contain the following information, along with any additional material as required by the procedure or instructor.

Each experiment contains title, purpose, detailed procedure or sketches or reference to the laboratory manual. Observations, recorded data and calculations are neatly presented with details including units and significant figures. Procedure, observation and conclusion are written in complete sentences in coherent manner with proper English syntax, passive past sentences. Do not copy the procedure given in the lab manual word for word. Observation should be recorded in your notebook as you do the experiment. It is better to include too many observations than too few. In some experiments, you may have to prove the structure of compound or to show by flow diagram, showing how the product is isolated. In some cases the physical constants, spectroscopic information and chemical reactivity results are interpreted as part of your conclusion.

Rules for Lab

1. Make-up will NOT be given. If you miss any of the assignments for any reason, it will be counted as a zero. I will drop the lowest lab report grade from final grade calculation.
2. If you missed a lab, you cannot submit the lab report for that lab.
3. Due to safety, students cannot come to the lab with more than 5 minutes delay.
4. All students need to have their own goggles.
5. Students without proper clothes for lab (dress code base on safety video) cannot participate in the experiment.
6. Make-up lab will not be given because all experiments need a group of students to perform experiment. Alternative lab (online, research, etc) will be allowed if and only if a verifiable, university approved document is submitted within 2 business days after the missing lab. The document should be submitted by Student conduct or Dean of students. Please refer to page 6 for more details (University rules).

Academic Misconduct (See Student Planner)

Forms of Academic Dishonesty:

1. **Cheating:** Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher.
2. **Plagiarism:** Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the Internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks.
3. **Multiple Submission:** Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.
4. **Conspiracy:** Agreeing with one or more persons to commit an act of academic/scholastic dishonesty.
5. **Fabrication of Information/Forgery:** Use or submission of contrived, invented, forged, or altered information in any assignment, laboratory exercise, or test; tampering with or production of a counterfeit document, particularly documents which make up the student's academic record. Examples: making up a source or citing nonexistent publication or article; representing made up data as real for an experiment in a science laboratory class; forging a change of grade or student withdrawal record; falsifying any document related to a student academic exercise.

Nonacademic Misconduct (See Student Planner)

The University respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Communication Expectations and Standards

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can take place in a seminar fashion. This will be accomplished by the use of the discussion board. The exact use of discussion will be determined by the instructor.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized by the use of the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.

COVID-19 Campus Safety Measures

To promote public safety and protect students, faculty, and staff during the COVID-19 pandemic, Prairie View A&M University has adopted policies and practices for the Fall 2020 academic term to limit virus transmission. - **Classroom Ingress/Egress** - Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Students should leave classrooms promptly after course activities have concluded, should not congregate in hallways and should maintain 6-foot physical distancing when waiting to enter classrooms and other instructional spaces.
- **Face-to-face Class** - To attend a face-to-face class, students must wear a face covering (or a face shield if they have an exemption letter). If a student refuses to wear a face covering, the instructor should ask the student to leave and join the class remotely. If the student does not leave the class, the faculty member should report that student to the Office for Student Conduct for adjudication. Additionally, the faculty member may choose to teach that day's class remotely for all students.
- **COVID-19 Guidelines for Student Conduct Adjudication** - The mandatory COVID-19 Training/Certification taken by all students serves as the 1st Warning for violation of COVID-19 Guidelines.
 - 1st incident: upon review of Incident Report and finding of responsibility — Conduct Probation
 - 2nd incident: upon review of Incident Report and finding of responsibility — Suspension

- **Personal Illness and Quarantine** - Students required to quarantine must participate in courses and course-related activities remotely and must not attend face-to-face course activities. Students should notify their instructors of the quarantine requirement. Students under quarantine are expected to participate in courses and complete graded work unless they have symptoms that are too severe to participate in course activities. Students experiencing personal injury or illness that is too severe for the student to attend class qualify for an excused absence. University Rules and Procedures

Academic Misconduct

Academic dishonesty is defined as any form of cheating or dishonesty that has the effect or intent of interfering with any academic exercise or fair evaluation of a student's performance. The college faculty can provide additional information, particularly related to a specific course, laboratory, or assignment.

You are expected to practice academic honesty in every aspect of this course and all other courses. Students who engage in academic misconduct are subject to university disciplinary procedures. As listed in the *University Administrative Guidelines on Academic Integrity*, the University Online Catalog, and the Student Code of Conduct, the following are examples of prohibited conduct. This list is not designed to be all-inclusive or exhaustive. In addition to academic sanctions, any student found to have committed academic misconduct that is also a violation of criminal law may also be subject to disciplinary review and action by the Office of Student Conduct (as outlined in the Student Code of Conduct).

Forms of Academic Dishonesty:

6. **Cheating:** Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
7. **Plagiarism:** Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying

another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;

8. Collusion: When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
9. Conspiracy: Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and
10. Multiple Submission: Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.

Nonacademic Misconduct

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the inability of other students to profit from the instructional program, or (3) campus behavior that interferes with the rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

Sexual Misconduct

Netiquette (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

Video Conferencing Etiquette

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. Before the class session begins, test audio, video, and lighting to alleviate technology issues.

Communication Expectations and Standards

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

Discussion Requirement

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized by the use of the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.
