Assignment Title or Grade Requirement	Description
	Students are to answer the discussion question for each week with an original comment (5-8 content sentences in length, worth 1.5 points). Your sentences must pertain to the content of the topic posted on Canvas. This category will be worth 15% of your final grade . The score range for each discussion is $0 - 1.5$ There will be 10 weekly discussions and one and half point for each discussion. It means you need to write one initial discussion and response to another student's response in a week. Topic for discussion of every week is mentioned in your
Discussion/Forum	semester calendar part of the syllabus. There will be no makeup in weekly discussions. Discussion must be posted in Canvas every week by the student. Canvas will be opened for posting in every week on Monday 10 AM and it will be closed on every week on Sunday 11.59 PM. You need to write a response to another student's posting of discussion. If you don't submit post the initial discussion and response on or before the above mentioned time, you will lose one and half point for that discussion.
	Point for initial discussion is one point and response to another student is half point. Total one and half point for each discussion.

Detailed Description of Major Assignments:

	your discussion and reply in Canvas. Your point is based on your proper description of the topic, content and number of minimum sentences.
	Each student will be required to participate in legal debate and to complete a paper related to course content. The topic for the paper is given below in the syllabus. You need to pick a topic from the syllabus only. This paper should include a cover page, introductory paragraph, body, conclusion, and reference page. This paper should be four pages, not including cover page or reference page. Papers should be typed, double-spaced, Times New Roman, 12 font, and in APA format per the 7 th edition of the manual. Penalty for late submission of legal debate paper is a three- points deduction per day off the paper score. After three days, late papers will not be accepted. All papers must be uploaded in Turnitin in CANVAS before or on the due date. Students should utilize the Writing Center and the library.
2. Legal Debate	The Writing Center The Writing Center provides well-trained peer tutors that assist students with writing assignments at any stage of the writing process. Tutors help students with various writing tasks from understanding assignments, brainstorming, drafting, revising, editing, researching, and integrating sources. Students have free access to Grammarly online writing assistance. Grammarly is an automated proofreading and plagiarism detection tool. Student must register for Grammarly by using their student email address. Paper	Legal Debate Paper: You need to pick one of the topic mentioned below and write 4 pages in APA style. You need to take a position either for or against your topic. For example, For Abortion you will be either for or against abortion. If you say you are for or against your topic, you need to establish your side with facts, case laws, arguments etc. You can't write for and against the same topic. Points will be deducted in that situation. There must be minimum three arguments and three relevant cases in your legal debate paper. This is an individual paper. You can't write about any other topic, you will receive '0' for Legal Debate paper.

	The legal debate will make up 7% of your final grade . Points will be deducted for serious errors and if you don't submit on time and don't follow the above rules. Grade A or B are based on your well organized writing, arguments, case laws cited etc.in you legal debate paper.

	Date for the submission of Legal Debate paper is mentioned in the semester calendar. No paper will be accepted after the last day of the class. Paper must be uploaded via Turnitin on CANVAS. Points will be deducted for late submission. Your paper will be checked for plagiarism. There will be three exams. Total points from exams are 70%; the first exam is 25%, second is the mid-term and it is 20% and the third exam is the final and it is 25%. In most instances, examinations consist of a mixture of multiple choice, true/false and short essays. The instructor, however, reserves the right to ask only one type of question (for instance, an exam that has only multiple-choice questions). You will be told about the exact format before each test. It is most ill advised to miss any of the exams! Make-ups will be given ONLY in instances of a documented emergency. THERE WILL BE ONLY "ONE" MAKE-UP EXAM. NO MAKE-UP OF MISSED EXAMS WITHOUT DOCUMENTATION OF A TRUE EMERGENCY OR CRISIS (e.g. death of someone close, hospitalization of oneself or one's child, or a spouse, suprise work audit, etc.). Expect such tests to be more challenging than regularly scheduled exams. 4. Case Briefs	Case Briefs is designed to check the knowledge of the students in criminal justice cases. Worth 8% of grade.
	Writing two case briefs. This is worth 8% of your final grade. Each brief should not be less than one and half pages. It must be typed, double-spaced and in APA

format per the 7 th edition of the manual. You need to submit both cases together in Turnitin on Canvas. In each case brief you need to write Name and number of the case, Facts of the case, Legal issue in that case, Decision by the court and Significance of the case . Use Microsoft Word. The case must be from the Text book and it must be an adult cases. You can't pick Juvenile Cases. Points will be taken for late submission and points will be taken for picking Juvenile cases.
You need to write a good case significance and mention more than two legal issues to get grade A or B in case briefs. You can submit on or before the last due date of the case briefs. You need to give two case briefs together and it is the responsibility of the student to give two case briefs together. If you submit only one case brief, you will get only maximum 5 points.
Date for the submission of case briefs is mentioned in the semester calendar. You must upload two case briefs together via Turnitin on Canvas. No case briefs will be accepted after last day of the class. Points will be deducted for late submission. Paper will be checked for plagiarism.

University Rules and Procedures

Academic Misconduct

Academic dishonesty is defined as any form of cheating or dishonesty that has the effect or intent of interfering with any academic exercise or fair evaluation of a student's performance. The college faculty can provide additional information, particularly related to a specific course, laboratory, or assignment.

You are expected to practice academic honesty in every aspect of this course and all other courses. Make sure you are familiar with the *University Administrative Guidelines on Academic Integrity*, which can be found on the <u>Academic Integrity webpage</u>. Students who engage in academic misconduct are subject to university disciplinary procedures. As listed in the *University Administrative Guidelines on Academic Integrity*, the University Online Catalog, and the Student Code of Conduct, the following are examples of prohibited conduct. This list is not designed to be all-inclusive or exhaustive. In addition to academic sanctions, any student found to have committed academic misconduct that is also a violation of criminal law may also be subject to disciplinary review and action by the Office of Student Conduct (as outlined in the Student Code of Conduct).

Forms of Academic Dishonesty:

- <u>Cheating</u>: Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
- <u>Plagiarism</u>: Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another

and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;

- 3. <u>Collusion</u>: When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
- 4. Conspiracy: Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and
- 5. <u>Multiple Submission</u>: Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.

Nonacademic Misconduct

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the inability of other students to profit from the instructional program, or (3) campus behavior that interferes with the rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

Sexual Misconduct

Sexual harassment of students and employees at Prairie View A&M University is unacceptable and will not be tolerated. Any member of the university community violating the university's sexual harassment policy will be subject to disciplinary action. In accordance with the Texas A&M University System guidelines, your instructor is obligated to report to the Office of Title IX Compliance (titleixteam@pvamu.edu) any instance of sexual misconduct involving a student, which includes sexual assault, stalking, dating violence, domestic violence, and sexual harassment, about which the instructor becomes aware during this course through writing, discussion, or personal disclosure. Student Academic Appeals Process

Authority and responsibility for assigning grades to students rest with the faculty. However, in those instances where students believe that miscommunication, errors, or unfairness of any kind may have adversely affected the instructor's assessment of their academic performance, the student has a right to appeal by the procedure listed in the University

Online Catalog and by doing so within thirty days of receiving the grade or experiencing any other problematic academic event that prompted the complaint.

Netiquette (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

Video Conferencing Etiquette

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. Before the class session begins, test audio, video, and lighting to alleviate technology issues.

Communication Expectations and Standards

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

Discussion Requirement

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings,

lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized by the use of the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.

COVID-19 Campus Safety Measures

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, PVAMU has adopted policies and practices to limit virus transmission.

- **Self-monitoring** Students should follow CDC recommendations for self-monitoring. Students who have a fever or exhibit symptoms of COVID-19 should participate in class remotely and should not participate in face-to-face instruction.
- Face Coverings Face coverings (cloth face covering, surgical mask, etc.) are recommended in classrooms, teaching laboratories, common spaces such as lobbies and hallways, public study spaces, libraries, academic resource, and support offices, and outdoor spaces where 6 feet of physical distancing is challenging to maintain reliably.
- **Physical Distancing** Physical distancing should be maintained between students, instructors, and others in course and course-related activities where possible.
- Personal Illness and Quarantine Students required to quarantine are to participate in courses and courserelated activities remotely and must not attend face-to-face course activities. Students should notify their instructors of the quarantine requirement. Students under quarantine are expected to participate in courses and complete graded work unless they have symptoms that are too severe to participate in course activities. Students experiencing personal injury or illness that is too severe for the student to attend class qualify for an excused absence.
