**Detailed Description of Major Assignments:** 

Assignment Title or Grade Requirement	Description		
HOMEWORK ASSIGNMENTS	There will be eight (8) Homework assignments and only the seven best scores will be considered for your final grade. You will have three attempts for each assignment.		
DISCUSSIONS	There will be eight (8) discussion questions and only the seven best scores will be considered for your final grade. For each question, you are supposed to provide your answer in plain English (at least two sentences) and comment on at least two responses from your classmates. Each Discussion will be graded out of 10 Pts.		
EXAMS	There will be four (4) timed (100 minutes) exams without multiple attempts. Only the three best scores will be considered for your final grade.		
ATTENDANCE	Attendance is mandatory in this course and 10% of your final grade will come from your attendance.		
FINAL PROJECT	Students will analyze the market dynamics of a specific product (e.g., milk, fruits, fuel) using price data to understand the forces of supply and demand. More details are provided at the end of this syllabus.

#### **Academic Misconduct**

Academic dishonesty is defined as any form of cheating or dishonesty that has the effect or intent of interfering with any academic exercise or fair evaluation of a student's performance. You are expected to practice academic honesty in every aspect of this course and all other courses. In addition to academic sanctions, any student found to have committed academic misconduct that is also a violation of criminal law may also be subject to disciplinary review and action by the Office of Student Conduct (as outlined in the Student Code of Conduct).

## Forms of Academic Dishonesty:

- 1. <u>Cheating</u>: Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
- 2. <u>Plagiarism</u>: Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;
- 3. <u>Collusion</u>: When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
- 4. Conspiracy: Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and
- 5. <u>Multiple Submission</u>: Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.

## **Nonacademic Misconduct**

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the inability of other students to profit from the instructional program, or (3) campus behavior that interferes with the rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

## Netiquette (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

## **Video Conferencing Etiquette**

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. ## **Communication Expectations and Standards**

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

## **Discussion Requirement**

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized by the use of the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.

## FINAL PROJECT

## Market Analysis Project: Supply and Demand through Price Data

Objective: To analyze the market dynamics of a specific product (e.g., milk, fruits, fuel) using price data to understand the forces of supply and demand.

Follow the following steps:

- 1) Select two (2) specific products that are readily available in your local market and have price data accessible through the COLI dataset, for a given location (preferably an urban area in Texas).
- 2) Gather historical price data for the chosen product. This data can be obtained from COLI dataset (<a href="https://subscribers-c2er-org.pvamu.idm.oclc.org/datasets.asp">https://subscribers-c2er-org.pvamu.idm.oclc.org/datasets.asp</a>). You can access the dataset through the library's website.
- 3) Research and identify the key factors that influence the supply and demand for the chosen product. This could include factors such as weather conditions, seasonality, government policies, etc.
- 4) Use the collected data to create graphical representations of the price overtime, while attempting to justify supply and demand movements that could explain the observed trend. Use Excel to draw your graph.
- 5) Based on the analysis, which recommendations can you provide to various market players (e.g., consumers, producers, and the government)? for businesses or consumers in response to these predictions.
- 6) Bonus: How are the observed price dynamics related to international markets?

Special instructions: After the groups have been formed by the instructor, each group will need to select two (2) goods and inform the teacher. There should be no overlaps between the groups. The list of products is provided in Canvas.
