

Detailed Description of Major Assignments:

Global Entrepreneurship - MACROECONOMIC PAPER

As a Term Project, students will prepare a short summary of an international economic subject of their own interest. Possible subjects include Brexit, Trade war with China, NAFTA/USMCA, Greece relationship with the Euro zone, Argentina Pesos crisis, Venezuela melt-down, Plaza accords and Japanese protectionism, Global supply chain in the age of Coronavirus, etc. To the extent applicable, tie your summary to an economic theory or concept(s) learned during the course. The typewritten summary should be double spaced and at least 4 pages in length, excluding sources, title paper, and using APA style. Let me know your choice by the end of second week. This term project which will be due before or on July 31st via Canvas "Turnitin".

Business Plan Project with BMC

The Business Plan Project consists of writing presentation components. Writing a business plan allow students the opportunity to gain an in-depth understanding of a particular business. This can a fun experience as you attempt to enlightenment about important business economic concepts. A properly written business plan can lay a strong foundation for future business success.

To maximize your enjoyment, choose businesses wisely. Individual students complete this assignment or teams of two students can be formed.

Presentations:

In class (before departure) and at the COB seminar (upon arrival) to and from SA.

Presentations help to refine students' oral communication skills, which is paramount within the 21st century workplace. Presentations will occur on the dates set on the course calendar. Each individual/team will have allocated time to cover their presentation items.

Students should try to effectively deliver their presentations and engage with the audience. Delivery is a measurement of communication skills and the ability to effectively convey information. The ability to engage is a measurement of students' ability to engage the audience and to ensure that the audience is understanding the presented informative material.

Entrepreneur Interview Project

This project will provide students with an applied experience to better understand the linkages between economics and entrepreneurship. It is also an opportunity for students to increase their global networks by interacting with a foreign entrepreneur.

Students who are traveling to South Africa (SA) will conduct an online video interview with a SA entrepreneur who is operating an official business in South Africa. Non-traveling students can conduct an interview with a US-based entrepreneur. Your interviewee should have primary responsibility for their business.

The complete guidelines will be provided a separate handout.

**Please note the following:

- the COB Seminal Presentation is required before your grades will be posted
- Professional conduct in SA will impact your class grade
- Presentation must address every aspect of the BMC.

In addition to newspapers, magazines, institutional websites note that at least two of your sources must be from scholarly articles that have been published.

Avoid Plagiarism: Plagiarism is the presentation of someone else's ideas, words, or artistic, scientific, or technical work as one's own creation. Using the ideas or work of another is permissible only when the original author is identified. Paraphrasing and summarizing, as well as direct quotations require citations to the original source. It is the student's responsibility to recognize the difference between statements that are common knowledge (which do not require documentation) and restatements of the ideas of others. Paraphrase, summary and direct quotations are acceptable forms of restatement, as long as the source are cited. Cut and paste from the internet are particularly an issue.

Academic Dishonesty Warning: Students who are caught providing exam answers to another student, or looking at another student's exam, or copying answers from another person on an exam, or discussing an exam with another person (except for me) during the exam period, or receiving aid on the exam from any other person during the exam period, will be given an F grade for the semester and reported to the Management & Marketing Department Head for further actions.

Course Procedures

All exams will be given in class during the regularly scheduled class sessions. The time and date of the final exam will be announced as soon as the University has made that information available. Bring a simple calculator to each exam. The use of programmable calculators and/or the calculator function on cellular phones is not permitted during exams. Please bring your student ID to each exam. You may be asked to show it before you turn in the exam. There will be no make-up exams. Exams will consist of both multiple-choice and essay questions. The multiple-choice questions will be similar to the online practice quizzes available at the following URL address: http://highered.mcgraw-hill.com/sites/. It is highly recommended that you review these online practice quizzes on a regular basis.

All known conflicts should therefore be drawn to my attention immediately. Failure to take any exam at the scheduled time may result in a score of zero for that exam. If you have an approved (university accepted) excuse, your final exam score may replace the missed exam score. If you miss an exam and fail to present your excuse the very next time you attend class, your excuse will not be accepted and you will receive a zero. You may not leave the classroom during an exam! If you are tardy for an exam, you will not be seated for that exam if a student has completed the exam and has left the classroom, and you will receive a zero.

Rolls will be taken at the beginning of every class period. In general, excessive absences, excused or unexcused, will affect your grade. Absences are accumulated beginning with the first day you are officially registered in this class. Only unexcused absences will reduce your attendance (bonus) grade. Ten(5) points will be deducted from the attendance points for every unexcused absence and for coming late or leaving the class before end of period. You must provide a University accepted excuse to have your absence excused. This written excuse must be presented on the very first day you return to class after an absence. Late excuses will not be accepted.

ATTENTION: The classroom door will be **closed** and **locked** five minutes from the time class starts. There is five minutes "grace period." If you arrive after the classroom door is **locked**, you have missed your opportunity to attend the class, and you will lose four attendance points. Do not knock, pound, or kick the door, or in any way attempt to gain attention or entry into the classroom. You will **not** be admitted if you are late for the class. Regardless of attendance, it is ultimately your responsibility to be aware of all announcements made in class on posted on eCourse and materials discussed in class. You are responsible for getting notes covering missed material; I am NOT a source of notes. Furthermore, leaving class before class is dismissed is not acceptable. If you have a legitimate reason for leaving class early, please bring it to my attention prior to the start of that day's lecture.

If there should be extra-credit assignments during the course of the semester, they must be turned in at the beginning of class on the day they are due. If you are absent, you **cannot** make up extra-credit assignments. Turning in extra-credit assignments early is always acceptable.

Your final class grade is your FINAL grade. I do not curve your final class grade. If your final class grade is 79.4%, you will receive a C for the semester. Do not waste your time or mine by asking me what you can do to make a better grade at the end of the term. I do not assign extra credit to individual students. However, if you suspect that I have made a clerical error in calculating and/or recording your final grade, please feel free to bring this to my attention as soon as possible and I will gladly recalculate your grade.

• Grading is usually a major area of concern for students. I am here to help you learn economics. Remember, I love economics and want to share that passion with you. I get no satisfaction from trying to fail students or lower their GPAs. However, that doesn't mean I accept "shoddy work" or "reward irresponsibility". If you are having trouble, *do not wait until near the end of the semester to let me know*! At that point there is little either of us can do to rescue your grade (I will not assign extra credit). Call, email, drop by my office, do something to let me help you! As soon as possible!

Semester Calendar: Weekly Course Calendar and Learning Objectives

Missed exam: Because excused absences sometimes occur, a student who misses 1 exam may have the missed exam score replaced by the final exam percentage score. A student who misses exam(s) without official excuse will receive a zero score for the exam(s). There are no exceptions to this rule.

Missed final exam: A student who misses the final exam will receive a zero score, except in extremely rare cases of documented dire personal need, in which case the student may qualify to receive an "incomplete" grade for the semester. **Lowest midterm exam score replaced by final exam percentage score**: Because legitimate circumstances can result in a low midterm score for a student, each student who completes all three exams during the semester **MAY** (depends on the circumstance) have the lowest midterm exam score replaced by the final exam percentage score (if the final exam percentage score is higher than the lowest midterm exam score).

What if I have another University-sanctioned event the day of the exam?

You must notify me via email at least two weeks before the exam. I may ask for documentation. A conflict exam will be offered. A fraternity or sorority event is not considered an official University event.

What if I have some other event the day of the exam, like concert tickets, a plane ticket or a Greek event? Take a different instructor this semester or take this class another semester. You WILL NOT be allowed to take the exam at another time.

What if I become ill or an emergency occurs the day of the exam?

Notify me as soon as possible, with official documentation. The exam will be waived and the weight will be added to the final. What if I accidentally or on purpose miss the exam?

You will get a 0 on the exam and this score cannot be replaced by a high grade on the final.

Self-Discipline: It is important to adhere to the course schedule and not fall behind on reading or practice problems. You should devote 6-12 hours per week on this course, attending class, reading the assigned textbook chapters/handouts, doing practice problems, doing unassigned problems from the textbook for your own use, doing practice exams, and taking exams. If you fail to devote 6-12 hours per week on these things then you should not be surprised to receive a D or an F for your semester grade.

University Rules and Procedures

Academic Misconduct

Academic dishonesty is defined as any form of cheating or dishonesty that has the effect or intent of interfering with any academic exercise or fair evaluation of a student's performance. The college faculty can provide additional information, particularly related to a specific course, laboratory, or assignment.

You are expected to practice academic honesty in every aspect of this course and all other courses. Make sure you are familiar with the *University Administrative Guidelines on Academic Integrity*, which can be found on the <u>Academic Integrity webpage</u>. Students who engage in academic misconduct are subject to university disciplinary procedures. As listed in the *University Administrative Guidelines on Academic Integrity*, the University Online Catalog, and the Student Code of Conduct, the following are examples of prohibited conduct. This list is not designed to be all-inclusive or exhaustive. In addition to academic sanctions, any student found to have committed academic misconduct that is also a violation of criminal law may also be subject to disciplinary review and action by the Office of Student Conduct (as outlined in the Student Code of Conduct).

Forms of Academic Dishonesty:

- <u>Cheating</u>: Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
- 2. <u>Plagiarism</u>: Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;
- 3. <u>Collusion</u>: When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
- 4. Conspiracy: Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and

- 5. <u>Multiple Submission</u>: Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.
- 6. Use of AI for essays or other assignments

Nonacademic Misconduct

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the inability of other students to profit from the instructional program, or (3) campus behavior that interferes with the rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

Sexual Misconduct

Sexual harassment of students and employees at Prairie View A&M University is unacceptable and will not be tolerated. Any member of the university community violating the university's sexual harassment policy will be subject to disciplinary action. Netiquette (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

Video Conferencing Etiquette

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. Before the class session begins, test audio, video, and lighting to alleviate technology issues.

Communication Expectations and Standards

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

Discussion Requirement

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized by the use of the spell-and-grammar check functions in word processing applications. Once the post(s) have

been typed and corrected in the word processing application, copy and paste to the discussion board.

COVID-19 Campus Safety Measures

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, PVAMU has adopted policies and practices to limit virus transmission.

- Self-monitoring Students should follow CDC recommendations for self-monitoring. Students who have a fever or exhibit symptoms of COVID-19 should participate in class remotely and should not participate in face-to-face instruction.
