Detailed Description of Major Assignments: (Consult the Calendar below for all due dates!)

Assignment Title or Grade	Description
Requirement  1. Exams (Altogether = 45% of final course grade)	Three non-cumulative multiple-choice exams will contain approximately 50 questions, respectively, and may be held online and may require use of the LockDown Browser (consult your instructor). The following campus facilities offer access to it: JB Coleman Library (rooms 210 and 210B and the Student Success Center on the third floor), MSC (1st floor main lab), Farrell Hall (1st floor main lab), Delco (room 301), Hobart Taylor (room 1A109), and E.E. O'Banion ("New") Science (room 123). No makeup is allowed unless there is a documented emergency.
2. Discussion Assignments (14% of final course grade)	Students are required to complete two sets of discussion assignments (four individual assignments, total): writing and posting 1) an analysis of a current event & discussion question (50 points), 2) an analysis of a current Texas public policy and suggestions (50 points), and 3) feedback to your peer's discussion post (20 points each, twice). Please read my detailed instructions and rubric on these assignments on our Canvas website and check your assignment due dates.
3. InQuizitive quizzes (13% of final course grade)	Your textbook comes with an interactive feature called "InQuizitive." You are required to answer all these questions. Unlike the actual exams, you can retake these quizzes as many times as you like. Each chapter will be worth 13 points. You can miss one chapter without penalty; in other words, only top scores from 10 chapters will be reflected in your final grade.

4. Writing Assignment (10% of final course grade)

Students must submit a research paper on how <u>judges are selected in the Texas judiciary</u>. Your paper must meet the following content, format and submission requirements:

### CONTENT REQUIREMENTS

- 1. Identify and explain the current TEXAS law regarding the selection of most judges in Texas.
- 2. Identify and explain at least two other types of judicial selection processes used in the U.S.
- 3. Choose whichever judicial selection method you think is best and give at least two criteria explaining how and why you made your choice. Possible criteria include: impartiality/independence, accountability and competence of judges.
- 4. Describe who may or may not benefit from the position you take in 3) above. Consider the impact on political parties, on justices and the individuals in the Texas court system. Also consider the impact in other areas, e.g., economic, political, social.
- 5. List at least two things you could do in order to engage the political process in Texas in pursuit of your position in 3) above, be specific.
- 6. Cite at least three (3) reliable, quality references within the body of the paper using the *Chicago Manual of Style's* parenthetical citation style. One of the citations MUST come from the class textbook (-10 points if this is not done). You must have at least three parenthetical citations in the body of the paper that correctly match the sources properly formatted in the Works Cited Page.

A paper with no parenthetical source citations in its body will receive a grade of 0.

A paper with no works cited section (a.k.a. list of reference list, a.k.a. bibliography) at the end of the body will receive a grade of 0.

### **FORMAT REQUIREMENTS:**

- 1. Typed, 2-3 pages (not counting Works Cited Page), 12-point font, double-spaced.
- 2. Student's name, instructor's name, POSC 2306, and the date.
- 3. A title is required, but a separate title page is not necessary.
- 4. An introduction with a thesis/statement of purpose in the first paragraph: "This paper will..."
- 5. A logically organized and sequenced body followed by a clearly stated conclusion.
- 6. Use of the <u>Chicago Manual of Style's</u> parenthetical citation format. Students must be very careful and pay attention to details when they examine and cite internet sources.
- 7. Use of footnotes or endnotes is prohibited.
- 8. Using encyclopedias, like Wikipedia, Ballotpedia, history.com, kids.law.com, etc. is prohibited (-10 points).
- 9. Use of word mixers like Spinbot is prohibited and will result in a grade of 0; no second chances will be allowed. Also, see the statements below regarding academic integrity, plagiarism, and generative artificial intelligence, such as ChatGPT.

#### SUBMISSION REQUIREMENTS

- 1. Your paper must be submitted in eCourses. You do NOT need a code; log into eCourses and click on the link that says, "Assignment #2: Research Paper," then click on the submission tab and follow the prompts to upload your paper.
- 2. Late submissions will not be accepted, so plan accordingly.
- 3. A paper placed in my office, in my mailbox or emailed will not be accepted for grading.

Papers are graded according to the following four criteria: 1) content; 2) organization; 3) quality of writing; and 4) quality of research sources and reference citation formats.

	Students are highly recommended to visit the Writing Center before they turn in their papers.
5. News Memo (7.5% of final course grade)	Students are required write a brief memo about current news articles related to the respective textbook chapters. There will be three sets of this assignment throughout this semester and each set will be worth 25 points.
6. Self-evaluation assignments (6% of final course grade)	Students are required to complete three sets of this assignment related to their self-development, time management, and performance evaluation. Please read my detailed instructions and rubric on these assignments on our Canvas website and check your assignment due dates. The assignments will be worth 20 points, respectively.
7. Plagiarism Test Certification (3% of final course grade)	Students are required to register for, then take this Plagiarism Certification Test as many times as necessary in order to obtain the Plagiarism Certificate. Submit the Plagiarism Certificate to receive full credit (30 points) for this assignment. 8. Class Contract & Syllabus Quiz (1.5% of final course grade)	Students are required to sign the class contract and complete the syllabus quiz in order to be part of this class. In the first week, I will go over all the information provided in the syllabus and the class contract to help students perform well in this course. If students do not accept the terms and conditions listed in the class contract, they are advised to change to a different class. The class contract is valid through the end of the semester.
9. Extra Credit Assignments (up to 3% of final course grade)	There will be several extra credit assignments throughout the semester. One example is to write a reaction paper about what you learned from the activities (simulations, games, or films) we did in class.

### **Course Procedures or Additional Instructor Policies**

Political Science Program Policy on Plagiarism: Plagiarism is a serious academic crime and the Political Science Program has a strict, rigorous enforcement policy for students who commit plagiarism. In general, plagiarism is using another person's or artificially generated program's words, statistics, and/or ideas as if they were your own. Plagiarism, which is formally defined in the University Rules and Procedures section of this syllabus, can come in many forms, such as directly quoting a source without quotation marks, taking another student's work, directly quoting a source without giving a reference citation, paraphrasing a source without giving a reference citation and so forth. It is incumbent on students to seek help from the instructor or other University resources to avoid even the appearance of plagiarism in their work. If in doubt, CITE THE SOURCE! Any student caught committing ANY type of plagiarism in a Political Science course will receive one OR MORE of the following punishments, depending on the severity of the offense and in accordance with the Student Code of Conduct:

- 1. Grade Penalty (an F for the assignment or for the course) in addition to cancellation of any extra credit points
- 2. Letter of Reprimand
- 3. Probation
- 4. Suspension
- 5. Dismissal from Academic Program
- 6. Expulsion from the university.

Students must consult the University's Code of Conduct for other forms of academic dishonesty and punishments.

Attendance Policy: This course will be <u>asynchronous (i.e., we are not meeting in person)</u>. I will upload weekly course materials on Canvas every Sunday afternoon. You do not have to finish each module by the end of our scheduled time. However, you cannot move on to next module unless you finish the previous one. So <u>please try to keep up with the schedule, stated in the syllabus.</u>

Late/Tardy Policy: 1) Assignments: No extensions will be allowed (with the exception of extraordinary cases in which prior instructor's consent is required before the deadline for the assignment). Students who do not submit their work on time will be penalized 10% of the maximum points for each day they do not submit their work. Work that is submitted four days or more after the deadline will receive a grade of zero for the assignment. The due dates of assignments are clearly marked in the course schedule and it is your responsibility to know when assignments are due. 2) I do not accept late extra credit assignments.

# Forms of Academic Dishonesty:

- 1. <u>Cheating</u>: Deception in which a student misrepresents that he/she has mastered information on an academic exercise that he/she has not learned, giving or receiving aid unauthorized by the instructor on assignments or examinations. Examples: unauthorized use of notes for a test; using a "cheat sheet" on a quiz or exam; any alteration made on a graded test or exam which is then resubmitted to the teacher;
- 2. <u>Plagiarism</u>: Careless or deliberate use of the work or the ideas of another; representation of another's work, words, ideas, or data as your own without permission or appropriate acknowledgment. Examples: copying another's paper or answers, failure to identify information or essays from the internet and submitting or representing it as your own; submitting an assignment which has been partially or wholly done by another and claiming it as yours; not properly acknowledging a source which has been summarized or paraphrased in your work; failure to acknowledge the use of another's words with quotation marks;
- 3. <u>Collusion</u>: When more than one student or person contributes to a piece of work that is submitted as the work of an individual;
- 4. Conspiracy: Agreeing with one or more persons to commit an act of academic/scholastic dishonesty; and

5. <u>Multiple Submission</u>: Submission of work from one course to satisfy a requirement in another course without explicit permission. Example: using a paper prepared and graded for credit in one course to fulfill a requirement and receive credit in a different course.

### PV's General Statement on the Use of Generative Artificial Intelligence Tools in the Classroom

Generative Artificial Intelligence (GAI), specifically foundational models that can create writing, computer code, and/or images using minimal human prompting, are increasingly becoming pervasive. Even though ChatGPT is one of the most well-known GAIs currently available, this statement includes any and all past, current, and future generations of GAI software. PVAMU expects that all work produced for a grade in any course, be it face-to-face or virtual, will be the sole product of a student's endeavors to meet those academic goals. However, should an instructor permit their students to use artificial intelligence as a resource or tool, students must not substitute the substance of their original work with the results of using such GAI tools. This clearly violates the University's Administrative Guidelines on Academic Integrity and its underlying academic values.

#### **Nonacademic Misconduct**

The university respects the rights of instructors to teach and students to learn. Maintenance of these rights requires campus conditions that do not impede their exercise. Campus behavior that interferes with either (1) the instructor's ability to conduct the class, (2) the ability of other students to profit from the instructional program, or (3) campus behavior that interferes with the rights of others will not be tolerated. An individual engaging in such disruptive behavior may be subject to disciplinary action. The Office of Student Conduct will adjudicate such incidents under nonacademic procedures.

#### **Sexual Misconduct**

Sexual harassment of students and employees at Prairie View A&M University is unacceptable and will not be tolerated. Any member of the university community violating the university's sexual harassment policy will be subject to disciplinary action. # **Makeup Work for Legitimate Absences**

Prairie View A&M University recognizes that there are a variety of legitimate circumstances in which students will miss coursework and that accommodations for makeup work will be made. If a student's absence is **excused**, the instructor must either provide the student an opportunity to make up any quiz, exam, or other work contributing to the final grade or provide a satisfactory alternative by a date agreed upon by the student and instructor. Students are encouraged to work with instructors to complete makeup work before known scheduled absences (University-sponsored events, administrative proceedings, etc.). Students are responsible for planning their schedules to avoid excessive conflicts with course requirements.

#### **Absence Verification Process**

All non-athletic absences (e.g., Medical, Death/Funeral, Court/Legal-related, etc.) for which a student seeks to obtain a valid excuse must be submitted to the Dean of Students/Office of Student Conduct, with supporting documentation, for review and verification. Please use the Online Reporting Forms to access/complete/submit the Request for a University Excused Absence form for an excuse. Upon receipt, a staff member will verify the documentation and provide an official university excuse, if applicable. # **Student Academic Appeals Process**

Authority and responsibility for assigning grades to students rest with the faculty. However, in those instances where students believe that miscommunication, errors, or unfairness of any kind may have adversely affected the instructor's assessment of their academic performance, the student has a right to appeal by the procedure listed in the University Online Catalog and by doing so within thirty days of receiving the grade or experiencing any other problematic academic event that prompted the complaint.

#### Participants should have a basic proficiency of the following computer skills:

- Sending and receiving email
- A working knowledge of the Internet
- Microsoft Word (or a program convertible to Word)
- Acrobat PDF Reader
- Windows or Mac OS
- Video conferencing software (Zoom)

### *Netiquette* (online etiquette)

Students are expected to participate in all discussions and virtual classroom chats as directed. Students are to be respectful and courteous to others on discussion boards. Foul or abusive language will not be tolerated. Do not use ALL CAPS for communicating to others AS IT CAN BE INTERPRETED AS YELLING. Avoid slang terms such as "wassup?" and texting

abbreviations such as "u" instead of "you." Limit and possibly avoid the use of emoticons. Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post, and the message might be taken seriously or sound offensive.

### **Video Conferencing Etiquette**

When using Zoom, WebEx, or other video conferencing tools, confirm the visible area is tidy, clear of background clutter, inappropriate or offensive posters, and other distractions. Ensure you dress appropriately and avoid using high traffic or noisy areas. Stay muted when you are not speaking and avoid eating/drinking during the session. Before the class session begins, test audio, video, and lighting to alleviate technology issues.

### **Technical Support**

### Communication Expectations and Standards

Emails or discussion postings will receive a response from the instructor, usually in less than 48 hours. Urgent emails should be marked as such. Check regularly for responses.

### **Discussion Requirement**

Online courses often require minimal to no face-to-face meetings. However, conversations about the readings, lectures, materials, and other aspects of the course can occur in a seminar fashion. The use of the discussion board will accomplish this. The instructor will determine the exact use of discussion boards.

It is strongly suggested that students type their discussion postings in a word processing application such as Word and save it to their PC or a removable drive before posting to the discussion board. This is important for two reasons: 1) If for some reason your discussion responses are lost in your online course, you will have another copy; 2) Grammatical errors can be greatly minimized using the spell-and-grammar check functions in word processing applications. Once the post(s) have been typed and corrected in the word processing application, copy and paste to the discussion board.

# **COVID-19 Campus Safety Measures**

In accordance with the latest guidelines from the PVAMU Health Services, the following measures are in effect until further notice.

- Students who are ill will be asked to adhere to best practices in public health, such as masking, handwashing, and social distancing, to help reduce the spread of illness across campus.
